Commissioner,
750 individual contractholders who renew in January have letters scheduled to be mailed informing them that their policies will be discontinued as of January 1, 2014.
Over the entire year, there will be about 3000 total individual policies discontinued, with notices mailed 90 days before the quarterly policy anniversaries.
I'll let you know the exact number of affected covered persons shortly, but the immediate rough estimate would be 4,500 total persons over 2014, with 1125 total related to the current letter.
