VIII. ADDITIONAL INFORMATION OR EXPLANATIONS. *(Indicate part of Report.)*

Part I: On the 2006 Form, Filer noted resignations from officer or director positions with the Oklahoma Academy for State Goals, Crowe & Dunlevy, and the Oklahoma Bar Association (listed, respectively, in this Part on lines 3, 4, and 6 of the 2006 Form). In ordinary leadership transition, Filer's duties as Chair of Board of City Rescue Mission (line 1 of 2006 Form) ended in approximately Sept. 2007. Filer still serves on the Board of Directors of City Rescue Mission (line 1 2007 Form).

Part I, Line 5, page 1: Filer joined the Board of Directors of American Heart Association in approximately Sept. 2007.

Part V: Listed on Line 1 of Filer's 2006 Form is a Federal Bar Association gift; it was a one-time gift for Filer's investiture ceremony. Accordingly, that gift is omitted from the 2007 Form. Filer had no other reportable gifts for 2007.

Part VI: The revolving lines of credit noted on Lines 3 and 4 of Filer's 2006 Report---i.e., Bank of America Cards 1 & 2---do not appear on the 2007 Report because in early August 2007 Filer obtained a home equity loan and almost completely (if not completely) eliminated the balances on these credit lines. On the last day of the reporting period in 2007, the balances on these lines had not risen to reportable levels. The home equity loan is not in itself reportable, so it is omitted from this Part.
