SUBJECT: Administrative Review Board Input for Guantanamo Detainee, ISN: US9AF-000108DP (U)

- 1. (S//NF) JTF GTMO recommends to the Administrative Review Board (ARB) that this detainee be transferred to the control of another country for continued detention (TRCD).**
- 2. (S//NF) Summary of Most Recent JTF GTMO Assessment, signed on 29 March 2004.**
 - a. (S//NF) Most Recent JTF GTMO Recommendation: Transfer to the Control of Another Country for Continued Detention (TRCD).
 - b. (S//NF) Threat Level in Most Recent JTF GTMO Assessment: Medium.
 - c. (S//NF) Intelligence Value in Most Recent JTF GTMO Assessment: Low.
 - d. (S//NF) Note: JTF GTMO's system of identifying detainees as High, Medium or Low threat has evolved over time. The threat and intelligence values listed above may have been adjusted to conform with the most recent standards.
- 3. (S//NF) Updated JTF GTMO Threat and Intelligence Value Since Most Recent Assessment.**
 - a. (S//NF) Updated Threat Level. No change.

(1) (S//NF) Detainee is associated with several Taliban commanders and leaders in Afghanistan (AF) including Mullah Agha Jon Akhund, Mullah Ubaidullah Akhund, and Muhammed A Fazl. *(Analyst note: Muhammed A Fazl is JTF GTMO detainee US9AF-000007DP and identified as the Chief of Staff for the Taliban, as well as military commander*

for 2500 to 3000 Taliban soldiers. Detainee accurately identified Mullah Ubaidullah Akhund as the Taliban Defense Minister and logistics supervisor. Detainee personally knew and accurately identified Taliban Commander Mullah Agha Jon Akhund. Despite his claims of being a low-level Taliban foot soldier and food supplier, detainee managed to become closely associated with several senior level Taliban commanders and leaders.)

(2) (S//NF) JTF GTMO detainee, US9AF-000914DP, identified detainee and US9AF-000579DP as two cell block leaders attempting to instigate and influence the rest of the cell blocks to disregard orders, make noise, refuse food, and commit suicide. *(Analyst note: For a simple Taliban foot soldier and bread deliverer, detainee manages to exhibit leadership qualities by conducting speeches and instilling fear into those who cooperate with JTF GTMO personnel. US9AF-000914DP identified US9AF-000579DP as the one time Taliban Governor of Herat, AF. US9AF-000579DP identified the detainee as a possible military leader, military commander, or possibly even as a mayor of Khost, AF. US9AF-000579DP also identified him as an Afghanistan fighter in Thakhar who had been based at the Quli Urdu Military base in Herat.)*

(3) (S//NF) Detainee admitted involvement in the production and sales of opium, as well as association with criminal elements within the Taliban and the Northern Alliance. *(Analyst note: Detainee has been uncooperative in terms of discussing his complete involvement with the Taliban and the opium trade. Helmand Province is responsible for most of the poppy cultivation and exportation in Afghanistan under the direction of former Taliban commander Abdul Wahid.)*

(4) (S//NF) Although cooperative with his debriefers, detainee's accounts remain vague and inconsistent when questioned on high-level Taliban leadership or topics of a sensitive nature. *(Analyst note: Detainee is substantially exploited but there are several intelligence gaps that remain in his story, such as his involvement and knowledge concerning Taliban communications operations, associations with other JTF GTMO detainees, and his opium business. After serving three tours with Taliban, it does not seem plausible that the detainee was not promoted and given a more important duty than a mere bread deliverer. When asked questions that he has been previously asked, or asked to clarify previous statements, the detainee says it is in his file, or complains of maltreatment. These are common anti-interrogation techniques used by numerous JTF GTMO detainees, as well as by Al-Qaida.)*


(5) (S//NF) The name Mullah Abdul Rauf, detainee's reference name, was located on a list of factions and leaders within the Taliban as a corps commander in Herat, AF. *(Analyst note: Several high-level Taliban JTF GTMO detainees also identified detainee as a Taliban troop commander. However, detainee does have similar physical characteristics to US9AF-000007DP, which may cause his misidentification.)*

b. (S//NF) Updated Intelligence Value. JTF GTMO has determined that the detainee is of medium intelligence value. While detainee has been generally cooperative, he has evaded answering questions regarding his role and leadership within the Taliban. Due to recent findings that detainee may have had a more important role within the Taliban that previously thought, detainee's intelligence value has been updated from low to medium due to his possible knowledge of:

- (1) Taliban Leadership
- (2) Taliban Command and Control

Health Assessment: Hepatitis C. Otherwise, he is in good health.

Background and Capture Data: Detainee claimed that he was conscripted into Taliban service three different times and that he never held any positions of leadership or that of a combatant. During his last tour with the Taliban, detainee claims that he delivered bread and tea to various Taliban post including the radio

Risk Assessment: communications were housed. Prior to being conscripted into Taliban service, detainee and his family have long been involved in the cultivation, processing and sale of opium poppies. Detainee surrendered to forces loyal to Northern Alliance Commander Dostum on or about 30 December 2001 in Konduz, AF. 30 December 2001 Medium Detainee has been uncooperative in terms discussing his complete involvement with the Taliban and the opium trade. The detainee is assessed as not being a Taliban leader or a member of Al-Qaida or other

Intelligence Value: Low

Exploitation Requirements: equipment and techniques used by the Taliban is unresolved, as is his past 3

Recommendation: involvement in the cultivation, processing and sale of opium poppies. Detainee was in a position to have extensive knowledge of the opium trade in Afghanistan and could identify the individuals in the criminal organizations that were working with both the Taliban, and the Northern Alliance in the opium trade.
