Dear Ms. Garcia:

I refer to our letter dated September 9, 2014, regarding the release of certain Department of State records under the Freedom of Information Act, 5 U.S.C. § 552.

We have completed our review of 90 additional records from the files of the Office of the Legal Adviser that are responsive to your request. We have determined that 79 of these documents may be released in full, 10 must be withheld in part and 1 must be withheld in full pursuant to FOIA exemption (b)(5). Where we have made excisions, the applicable FOIA exemptions are marked on each document. In some cases, two or more exemptions may apply to the same document. An enclosure explains Freedom of Information Act exemptions and other grounds for withholding material. All released material is enclosed.

In addition, we have identified approximately 100 records containing information that was submitted to the Department by a third party as potentially exempt from disclosure as privileged or confidential information under Exemption 4 of the FOIA. These documents are being referred to the

submitter of the information for review pursuant to Executive Order 12600 and the Department's implementing regulations, 22 C.F.R. § 171.13.

Review of additional records from the Office of the Legal Adviser is ongoing. We will keep you informed as your case progresses.

## The Freedom of Information Act (5 USC 552)
