On 8DEC03, Special Agent Scott McAllister (Florida Department of Law Enforcement) along with Special Agent Tom Baugher (Federal Bureau of Investigation) and Detective James LaPlante (Sarasota City Police Department) interviewed a confidential informant, under control of the Detroit office of the Federal Bureau of Investigation.

The source provided information regarding Wissam HAMMOUD (Threatnet case # 03-38). HAMMOUD allegedly recently traveled to the Middle East, along with Jaleel "George" SAAD, reported to be the head of the Syrian Socialist Party. The purpose of the trip was for HAMMOUD to possibly export olive oil to the United States. The source reports that the Syrian Socialist Party is similar in beliefs as the Nazi party was in the 1940's.

The source reported to police that HAMMOUD is very paranoid and has surveillance cameras positioned outside his residence, with vcr recorders in his garage and television monitors inside his residence.

The source also identified a photograph of Ron BARCO as a friend of HAMMOUD who currently holds HAMMOUD's stash of (legitimate) weapons. Also a neighbor of HAMMOUD, who is an ex-marine, is also holding some legitimate weapons for HAMMOUD.

The source also spoke to Muneer ARAFAT as the Imam of the local mosque and that ARAFAT was a member of the Islamic Brotherhood, who follows a radical belief and teachings of ALBAZ, and wishes harm to the United States. According to the source, ARAFAT is reported to be in the Middle East raising money for the local mosque. (SA Baugher verified this information regarding ARAFAT being out of the country at this time).

HAMMOUD has pointed out the SouthTrust building (housing the offices of the FBI) and stated that he wanted to drive a gasoline truck into the building for "the pain and suffering they have caused (him)." Also, HAMMOUD has spoke about trying to locate the ATF source (who assisted the ATF in his investigation and arrest) in Ohio in order to kill him.

On 11DEC03, Special Agent Scott McAllister (FDLE) and Special Agent Tom Baugher (FBI) meet with a source regarding Wissam HAMMOUD. The source had contact with HAMMOUD and told the Agents that HAMMOUD told the source in a recorded conversation that he had service through "Autotrac" and successfully located the address in Ohio of the source and Special Agent from the ATF investigation that HAMMOUD was indicted for. Due to HAMMOUD demeanor and affinity to weapons, this is considered a viable threat.

Immediately after the meet, ATF was notified of the danger to the Agent and source. HAMMOUD is due to be released from his in-house monitoring and reporting towards the end of December. That would allow him the freedom to travel out of the area.

The source will continue close contact with HAMMOUD and record all telephone and in person conversations and maintain an open line of communication with the Special Agents on a daily basis. Investigation to continue.



SA McAllister interviewed Beatrice BLACKBULL (2008 12th Street West, Bradenton, 941.748.5898, DOB: 2/20/1956) and learned that BLACKBULL moved in on

On 20FEB04, Special Agent Scott McAllister and FBI Special Agent Tom Baugher interviewed an individual ("Source") who has agreed to testify at trial, who provided the following information:

From 11/23/04 until 1/21/04 Source was in the United Arab Emirates (UAE) attempting to raise money for the Islamic Center of Sarasota and Bradenton (ISSB). The ISSB requested that Source travel to raise money for a new mosque that they hope to build in Sarasota. For his efforts, Source was promised 20% of all monies raised. Source's plane ticket cost \$1,800 and the ISSB paid half of this amount.

As a general matter, Source was unsuccessful in raising any money. Source explained that the UAE is making it extremely difficult for its citizens to donate money to Muslims in the United States due to a fear that this acts will be criminalized under new U.S. anti-terrorism laws and also out of a general sense of retribution for the U.S. restricting its citizens' donations abroad.

Source kept records of everyone who promised to donate money to the ISSB. All these individuals told Source that once he returned to the U.S. to mail them an official letter requesting a donation at which time, the donor would send a check or give the letter to their lawyer to disburse the donation.

Source was invited to speak at Hamed Hassen Erqueit's house one night. Erqueit was hosting a dinner party and there were approximately 40 people in attendance. Erqueit is the Assistant Minister for Islamic Affairs in the UAE. Source spoke on the nature of Islam in the U.S. and other general matters.

Husni Albarguthi is the current Imam of the ISSB. Albarguthi is working for free. Albarguthi is married to Ishaq Abuayyash's sister. Ishaq lives at 101 Nature's Circle, Sarasota, Florida. Albarguthi also bought Wissam Hammoud's former store, Budget Mobile, for the sum of \$10,000.

Khalid Sulieman moved out of Source's house in September 2003 and is slowly paying back the money he owes Source. Sulieman is the main cook at Sahara restaurant and works as a detailer at Gulf Coast Auto.

Source has an offer from the Boca Raton Islamic Center, P.O. Box 3364, Boca Raton, Florida 33427 to be the Imam and principal of the elementary school. Source's salary would be \$3,000 per month.

During his time in the UAE, Source noticed that there is a movement to boycott U.S. and British goods because of the invasion of Iraq. Source stated that the media in the UAE propagates the myth that the U.S. hates Muslims. Muslims there believe U.S. Muslims have restricted freedom of movement, assembly, and worship. Source stated that Arabs do not trust Al Jazerai news media because they think it is controlled by the Israeli Mossad and is attempting to divide and conquer them.
