Dear Ms. Garcia:

I refer to our letter dated April 8, 2014, regarding the release of certain Department of State records under the Freedom of Information Act, 5 U.S.C. § 552.

We have completed our review of 33 additional records from the files of the Office of the Legal Adviser that are responsive to your request. We have determined that all 33 of these documents may be released in full. All released material is enclosed.

In addition, we have identified approximately 50 records containing information that was submitted to the Department by a third party as potentially exempt from disclosure as privileged or confidential information under Exemption 4 of the FOIA. These documents are being referred to the submitter of the information for review pursuant to Executive Order 12600 and the Department's implementing regulations, 22 C.F.R. § 171.13.

Review of additional records from the Office of the Legal Adviser is ongoing. We will keep you informed as your case progresses.
