Dear Ms. Bailey:

I refer to our letter dated November 12, 2015, regarding the release of certain Department of State records under the Freedom of Information Act ("the FOIA"), 5 U.S.C. § 552.

The Department has completed the review of the records retrieved from the supplemental search of the Office of the Secretary. We have determined that of the remaining 14 documents, 11 may be released in full and 3 may be released with excisions. The Department has also completed the review of materials provided by former Department employees Huma Abedin, Cheryl Mills, and Jacob Sullivan. We have determined that the remaining responsive document from these materials may be released in full.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable FOIA exemptions are marked on each document. All released material is enclosed.

In processing the documents retrieved in our original searches, the Department determined that two of those documents had originated with other agencies. Both of those documents were referred to other government agencies for review and direct response to you.

All,

Here's Nahla's quick read-out of how Al Jazeera framed the interview.

Nahla says Mr. Hussein gave a very strong interview. She thought he very effectively quoted an earlier Egyptian interlocutor calling for reason and peaceful solutions. He also quoted Koranic verses on non-violence, forgiveness, and not killing, which should play very well with the audience though it was met with a rather hostile reaction from the interviewer, who seemed caught off-guard.

After the interview, AJ news reported that Mitt Romney is getting criticized by other Republicans for taking advantage of the crisis for political motives.

Following the news, there was an interview with Dr. Mohamed Al-Jawadi, a historian and political analyst who was asked if Secretary Clinton's statements are enough to stem the tide of outrage. He said the State Department has achieved cooperation with the Islamic work by supporting and respecting the people's aspirations and now has strong relationships based on mutual respect and respecting laws, but there are those in Egypt, Libya, Yemen, and the US who wish to destroy that cooperation. When asked how to prevent future violent incidents at US Embassies, he emphasized the importance of strong judicial institutions to address charges of breaking laws and denigrating religions, so the cases may be settled within legal systems. Educating people about religions and dispelling misconceptions, especially about Islam, is also very important.

RIYADH (Reuters) - Saudi Arabia's Grand Mufti, the highest religious authority in the birthplace of Islam, on Saturday denounced attacks on diplomats and embassies as un-Islamic after deadly protests against a U.S.-made film mocking Islam's founder.

Sheikh Abdulaziz bin Abdullah Al al-Sheikh also called on governments and international bodies to criminalise insults against prophets and excoriated the film that has prompted a wave of fury across the Middle East.

"It is forbidden to punish the innocent for the wicked crimes of the guilty, or to attack those who have been granted protection of their lives and property, or to expose public buildings to fire or destruction," he said in a speech carried by state news agency SPA.

Describing the release of the crudely made short film as "miserable" and "criminal", he added that attacks on the innocent and diplomats "are also a distortion of the Islamic religion and are not accepted by God".

At least nine people were killed after noon prayers on Friday in demonstrations across the Middle East.
