Dear Mr. Marshall:

I refer to our letter dated May 31, 2016, regarding the release of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552.

Our review is ongoing, and we have determined that 16 additional documents may be released in full, 130 may be released with excisions, and 4 must be withheld in full. All released material is enclosed.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable exemptions are marked on each document. All non-exempt material that is reasonably segregable from the exempt material has been released. For the documents withheld in full, we have cited FOIA Exemptions 5 and 6, 5 U.S.C. §§552 (b)(5) and (b)(6).

A Wake-Up Call for the US and China: Stress Testing a Symbiotic Relationship

Stephen S. Roach

Since the turn of the century, no two nations have been more important in driving the global economy than the United States and China The American consumer has been the dominant force on the demand side of the global economy, whereas the Chinese producer has been the most powerful force on the supply side. Few argued with the payback. Over the four and half years ending in mid-2007, world GDP growth averaged nearly 5% – the strongest and most sustained boom in the global economy since the early 1970s.

But now both engines are sputtering, with ominous consequences for a world in its worst crisis since the 1930s. This poses great challenges for each nation, as well as to the bilateral relationship between them. There is hope but it comes with a big "if" – if China and the United States pull together in forging common solutions. However, if these two nations end up at odds with one another, they will both suffer – with dire consequences for the rest of a crisis-torn global economy. The stakes are enormous. There is no margin for error.

A World in Crisis

No nation has been spared the impacts of this wrenching financial crisis and recession. While America's so-called subprime crisis may have been the spark that ignited the inferno, every region in this globalized world is now faltering in lock-step fashion. That includes China – long the most resilient economy in an otherwise weakened world. And it includes the rest of an increasingly China-centric Asia, where all economies either have tumbled into outright recession or are slowing sharply. Ten years after the Asian financial crisis wreaked havoc in the region, a new crisis is at hand. Far from having decoupled from the rest of the world, Asia's problems – and China's in particular – are tightly linked to the crisis and recession that started in America and have since spread like wildfire throughout the developed world.

These problems have arisen, in large part, because of the unbalanced state of both economies. America's excess consumption model is in serious trouble because the asset bubbles that have long supported it – property and credit – have both burst. China's export-led growth model is in trouble because it is being adversely impacted by a massive external demand shock that is very much an outgrowth of America's post-bubble compression of consumer demand. The rest of Asia – export-dependent economies, which have become tightly integrated into a China-centric supply chain – has nowhere to hide. Ten years after the wrenching upheaval of 1997-98, Asia is facing another crisis.

Significantly, these imbalances did not occur in isolation from each other. America's consumption bubble was, in effect, sourced by an equally destabilizing Asian export bubble. And now both sets of bubbles have burst – on the demand side as well as on the supply side of the global economy. It had to happen at some point: Long simmering global imbalances have finally come to a head in a post-bubble world (see Figure 1)

China: Unbalanced and Unstable

During the boom, China's imbalances actually worked in its favor. Over the 2001 to 2007 period, the export share of Chinese GDP nearly doubled from 20% to 36% while the global export share of world GDP went from 24% to 31% (see Figures 2 and 3). In other words, China's timing was perfect. It upped the ante on its export dependence at precisely the moment when global trade enjoyed its most spectacular growth. That effectively turbo-charged China's benefits from the strongest global boom since the early 1970s, powering GDP growth at a 10.4% average rate in the seven years ending in 2007.

That was then. Reflecting the impacts of a rare synchronous recession in the US, Europe, and Japan, the world trade boom has now gone bust. And Chinese exports, which had been surging at a 25% year-over-year rate as recently as mid-2008, reversed course with a vengeance – ending the year in a mode of outright contraction, falling by 2.8% in December.

With exports such a large and rapidly expanding slice of the Chinese economy, little wonder measures of aggregate activity slowed in an equally dramatic fashion. Industrial output increased only 5 7% in December – one-third the average 16 5% growth pace of the preceding five years. And real GDP growth ended the year at just 6.8% – in sharp contrast to the nearly 12% pace of the preceding three years

China's growth compression as reported on a year-over-year basis masks the severity of its recent downshift. A translation of these figures into sequential quarterly changes, such as those reported by the United States, suggests that Chinese GDP and industrial output growth were in the flat to slightly negative territory as 2008 came to an end. As seen from this real-time perspective, the Chinese economy hit a wall late last year. Such an abrupt downshift implies it will be extremely difficult for China to achieve the government's 8% GDP growth target for 2009. An outcome closer to 6%, or even lower, is a distinct possibility. China is hardly an oasis of prosperity in a crisis-torn world.

For a nation long focused on social stability, this growth shortfall is a worrisome development. It has already taken a serious toll on Chinese employment. The government has now acknowledged job losses in coastal export manufacturing businesses of over 15% – or 20 million workers – of the nation's pool of some 120 million migrant workers. If the export and GDP shortfall persists, more slack would open up in the Chinese labor market – raising long dreaded risks of worker unrest. I remain convinced that the Chinese leadership will do everything in its power to avoid such an outcome. But in this global recession, the challenge is daunting, to say the least.

Asia: China-Centric and in Peril

It has become conventional wisdom to proclaim that the 21st century would be the Asian Century. China's miraculous development story is central to this vision – a transformation that many believe would inevitably push the pendulum of global power from West to East. It's hardly an exaggeration to claim that such a tectonic shift would turn the world inside out. The Asia Dream is an exciting and powerful story – a magnet to financial and human capital from all over the world.

I suspect it may be premature to crack out the champagne The Asian century is hardly as preordained as most seem to believe. The main reason, in my view, is that the region continues to rely far too much on exports and external demand. Developing Asia's export share hit a record high of 47% last year – up ten full percentage points from levels prevailing in the late 1990s (see Figure 4). That hardly speaks of a true economic power that has become capable of standing on its own.

At the same time, there can be no mistaking the increasingly China-centric character of the Asian economy – another dimension of the region's search for growth. As China boomed, the rest of Asia was more than happy to go along for the ride. A China-centric supply chain led to increasingly tighter pan-regional integration, with assembly lines in China drawing freely on inputs and components from Japan, Korea, Taiwan, Malaysia, Singapore, Indonesia, and elsewhere in the region. Yet that dependence cuts both ways – a two-way causality that is now complicating the here and now of the Asian century. As noted above, the China boom was itself very much tied to the record surge in global trade. But now with global trade contracting for the first time since 1982, China's export-led impetus has been quick to follow.

This has hit China-centric Asia extremely hard. The December 2008 export comparisons were nothing short of disastrous for the other major economies in the region: For example, Taiwan's exports were down an astonishing 42% y-o-y, with the Chinese piece off 56%; Japan's exports plunged 35%, with the Chinese piece off 35%; and Korean exports fell 17%, with the Chinese piece also off 35%. In all three of these cases, China had become each country's largest trading partners in recent years – accounting for 28% of total Taiwanese exports, 23% of Korean exports, and 16% of Japanese exports. But now that the Chinese export machine has screeched to a standstill, the rest of the region has weakened even more. This puts an Asian spin on an old adage. When China sneezes, the rest of Asia catches a bad cold.

I am convinced that the Asian century is coming. But the risk is that it may take a lot longer than widely presumed. All this underscores the biggest test to the Asian century – the ability of the region to stand more on its own in the event of an external shock. In the late 1990s, it was an external funding shock. Today, it is an external demand shock. These developments should put the region on notice that its leadership agenda is far from complete. Until export-led growth gives way to increased support from private consumption, the dream of the Asian century is likely to remain just that.

America: Bubble-Prone and Externally Dependent

There can be little doubt that this global crisis started in America. The ever-deepening recession in the US economy is very much an outgrowth of a massive post-bubble shakeout. It began with housing but has now spread to the biggest sector of all – the American consumer. At is peak in early 2007, US consumption accounted for fully 72% of real GDP – a record for the United States, and for that matter, a record for any major economy in the modern history of the world (see Figure 5).

The problem with this consumption binge is that it was not supported by the US economy's underlying income generating capacity. In the now-ended expansion, private sector labor compensation expanded at an unusually sluggish pace – falling over \$800 billion (in real terms) below the trajectory of the previous four business cycles (see Figure 6). The confluence of subpar job growth and relative stagnation of real wages left consumers well short of the labor income that would typically support booming consumption. But that didn't stop the American consumer. Drawing freely on asset appreciation – first equities and then housing – consumers uncovered new sources of purchasing power. The credit bubble was icing on the cake – enabling homeowners to extract equity at little cost from ever-rising home values and then use the proceeds to fund current consumption and build saving for the future. Net equity extraction soared from 3% of disposable personal income in 2000 to nearly 9% in 2006 (see Figure 7).

There are important consequences of such a bubble-dependent consumption and saving strategy. Significantly, by shifting the mix of consumer support from income to assets, the United Sates drew down its domestic saving rate to rock bottom levels. The net national saving rate – the sum of household, business and government saving after adjustment for depreciation – plunged to a record low of 1.8% of national income over the 2002-07 period, and then actually tumbled into negative territory in 2008 (see Figure 8). The global consequences of this development are profound: Lacking in domestic saving, the United States was forced to import surplus saving from abroad in order to grow – and run a massive current account deficit in order to attract the capital.

The saving shortfall of a bubble-prone US economy is a major source of vulnerability. During good times, it made America increasingly dependent on foreign lenders, such as China, to fund economic growth. During bad times – especially in the aftermath of the bursting of the property and credit bubbles – it triggered a massive consolidation of asset-dependent US consumption. Real consumption expenditures fell at a 3.6% average annual rate in the final two quarters of 2008 – the first time in the post-World War II era when consumer demand fell by more than 3% for two consecutive quarters.

Despite the unprecedented contraction of consumption in late 2008, there is good reason to believe the capitulation of the American consumer has only just begun. The consumption share of US GDP has fallen only about one percentage point from its 72% peak – still leaving this gauge four full percentage points above the pre-bubble norm of 67% that prevailed from 1975 to 2000. On this basis, only about 20% of the consumer's

mean reversion has been completed. Notwithstanding the extraordinary monetary and fiscal stimulus measures that have recently been put in place by US authorities, the post-bubble deleveraging of the American consumer is likely to be an enduring feature of America's macro landscape over the next 3-5 years.

Therein lies the essence of a massive and sustained global demand shock. The American consumer is the biggest consumer in the world (see Figure 9). And US consumption growth has long outstripped far more sluggish gains elsewhere in the developed world. Little wonder the post-bubble capitulation of the American consumer proved so decisive in undermining the external demand underpinnings for China and for the rest of export-dependent Asia. Nor is it likely to be over quickly. This multi-year headwind imparted by a sustained weakening in the growth of US consumption could well be the most powerful force shaping the demand side of the global economy for years to come.

Mounting Bi-Lateral Tensions

The current global crisis poses new challenges to the relationship between the United States and China – quite conceivably the world's most important bilateral relationship of the 21st century. Those challenges were underscored in the recent Senate confirmation hearings of America's new Treasury Secretary, Timothy Geithner, when he accused the Chinese of currency manipulation. Moreover, with the US in recession and unemployment high and rising, there is good reason to fear that Geithner's comments were just a warning shot of more China bashing on the horizon.

This is an unfortunate outgrowth of the blame-game mentality that has long been prevalent in Washington. During tough times, US politicians apparently need scapegoats to deflect attention away from the role they have played in creating serious problems. Wall Street is being singled out for causing the financial crisis – despite regulatory and central bank complicity – and China, with its large bi-lateral trade deficit with the United States, is being blamed for the pressures bearing down on American workers.

Washington's "logic" for turning tough on China trade policy is based largely on three factors – an outsize bilateral trade deficit between the two nations that hit a record \$256 billion in 2007, long-standing claims of RMB currency manipulation, and a seemingly chronic stagnation of real wages for American middle class workers. Fix the China problem, goes the argument, and unfair pressures on US workers will be relieved.

This argument is deeply flawed. The main reason is that the US-China trade deficit did not arise in a vacuum. As noted above, a bubble-prone, saving-short US economy needs to import surplus saving from abroad in order to keep growing. That also means it must run massive current account and trade deficits to attract that capital. The US-China trade deficit, along with deficits with 100 of America's other trading partners is, in fact, an important outgrowth of that problem. America has a multi-lateral trade imbalance – not a bilateral problem driven by unfair Chinese competition. China has the largest bilateral

piece of America's multilateral deficit – not because of the value of its currency but mainly because of conscious outsourcing decisions of US multinationals.

Nor is the evidence on the so-called undervaluation of the Chinese renminbi nearly as conclusive as many US experts seem to believe. For starters, the RMB is up nearly 21% against the US dollar (in real terms) since China abandoned its currency peg over three years ago. Moreover, recent academic research puts the RMB's multilateral undervaluation on the order of only 10% – hardly a major advantage for China (see Yin-Wong Cheung, Menzie D. Chinn, and Eiji Fujii, "China's Current Account and Exchange Rate," a January 2009 working paper of the US National Bureau of Economic Research). Significantly, these same researchers go on to demonstrate that China's bilateral and multilateral trade flows are not nearly as sensitive to movements in its currency as the RMB bashers would want to believe.

Nevertheless, if US-China trade is diminished or closed down through forced RMB revaluation, tariffs, or other means, a saving-short US economy will still need to run a large multi-lateral trade deficit. That means it will simply end up shifting the Chinese piece of its external imbalance to another trading partner. To the extent that shift is directed toward a higher-cost producer – most likely the case – the outcome will be the functional equivalent of a tax hike on the already beleaguered American middle class But it won't stop there. Undoubtedly, Chinese currency managers would retaliate by reducing their purchases of dollar-denominated assets. And that would push the world's two great powers all the closer to the slippery slope of trade protectionism.

Avoiding such an outcome – strikingly reminiscent of the trade wars of the 1930s triggered by America's infamous Smoot-Hawley tariffs – poses a major challenge to the body politic of both nations. That's particularly true for America's new president. Campaigning on a platform of support for beleaguered middle-class American workers, Barack Obama underscored his concerns about real wage stagnation in an era of unfettered globalization. The real wage issue is a serious issue. However, the challenge for Washington is to determine the linkage between this issue and trade policy. It may well be that real wage stagnation is related more to America's under-investment in human capital – especially, lagging educational reforms and re-skilling programs in an era of rapid IT-enabled globalization – than it is to cross-border trade pressures. It may also be that trade deficits are far more a function of flawed policies that discourage saving – a problem that s now going from bad to worse in an era of trillion dollar budget deficits. Resolving this dilemma, without derailing globalization, will be an early and important leadership test for President Obama.

Don't Count on Symbiosis

In economic terms, there can be no mistaking the natural symbiosis that has long existed between America, the consumer and low saver, and China, the producer and high saver. But this complementarity cannot be taken for granted as a co-dependence that will forever cement the bi-lateral ties between these countries. In fact, it may well be that US-

Chinese symbiosis is nothing more than passing phase – reflecting a coincidence of mutual interests that will exist for only a relatively brief period of time. Yes, as long as a saving-short US economy continues to run massive current-account deficits to support the excesses of personal consumption, it needs a lender like China to provide foreign capital. And as long as an excess saving Chinese economy needs export-led employment growth to maintain social stability, it needs the world's largest consumer to absorb its output.

But what happens if those conditions change? If America starts to save more – a distinct possibility for its over-extended post-bubble consumers – the need to borrow surplus saving from China will diminish. Conversely, if China starts to spend more – an equally likely possibility in light of its excessive reliance on exports and investment – it will have less surplus saving to lend to the United States. If both of these adjustments are perfectly timed to occur at precisely the same moment, it is possible to envision an uninterrupted symbiosis. The odds of such an exquisitely synchronized rebalancing of both economies are extremely low, in my view. That suggests the growing likelihood that symbiosis is likely to give way to disequilibrium – adding a new source of tension to the US-China relationship.

Unfortunately, that's not the only source of economic tension between the United States and China. Over the 2005-07 period, fully 45 pieces of anti-China trade legislation were introduced in the US Congress. While none of these bills passed, that may change. As the US unemployment rate now mounts in an ever-deepening recession, the politics of trade frictions may well gather greater support. Treasury Secretary Geithner's warning on Chinese currency manipulation is especially worrisome in that regard. The same can be said of the "Buy America" provisions that have slipped into America's recently enacted stimulus package.

At the same time, China must also be sensitive to the impacts of its export-led growth model on its trading partners. Any subsidies – either to its own domestic wages or to its currency – take on heightened importance as China's stature in world trade grows. As now the second largest exporter in the world, China can hardly afford to take that responsibility lightly. Moreover, if China competes unfairly by ignoring environmental degradation and pollution, the world pays a much greater price for the cross-border labor arbitrage than a simple comparison of wages would suggest. To the extent that cost-effective outsourcing ignores environmental considerations, the real wage squeeze in relatively "greener" economies may be all the more acute.

Resolving the complexities of the US-China economic relationship is an urgent challenge for an unbalanced global economy. As a crisis-torn world now moves into a severe recession, the stakes can only grow larger. As both the US and Chinese economies evolve and change, a fleeting state of symbiosis could well give way to heightened tensions. The time to diffuse those tensions is now – before it's too late.

China's Policy Imperatives

Ironically, China saw many of these problems coming. Two years ago, Premier Wen Jiabao warned that the Chinese economy was "unstable, unbalanced, uncoordinated, and unsustainable." Similar vulnerabilities were anticipated in the 1 hth Five-Year Plan enacted in 2006, which stressed China's need to embark on a major structural transformation from export- to consumer-led growth.

But the government's execution of this aspect of its plan was lacking. In particular, it failed to build out an institutionalized safety net – the support system necessary to temper the fear-driven precautionary saving that inhibits the development of a more dynamic consumer culture. As a result, the consumption share of Chinese GDP fell to a record low of 36% in 2007 – underscoring the dark side of China's macro imbalances that is now so problematic in this global crisis (see Figure 10). A severe external demand shock found an unbalanced Chinese economy without a back-up plan.

A pro-consumption rebalancing is the only sustainable answer for China. Pro-active fiscal stimulus measures, such as the recently announced RMB4 trillion infrastructure-led investment initiative, can help temporarily. Such efforts borrow a page from China's counter-cyclical script deployed in the Asian financial crisis in the late 1990s and again in the mild global recession of 2000-01. But these actions are not enough to compensate for the structural vulnerabilities that China's externally-dependent growth model now face as American consumers begin a multi-year retrenchment.

China needs to be bold and aggressive in framing pro-consumption policies. It should start by announcing major initiatives on the safety net front Specifically, China should sharply expand the funding of its national social security fund, which currently has only a little over US\$70 billion in assets under management – not even enough to provide \$100 of per capita lifetime retirement income for an aging Chinese population. China also needs to move quickly in establishing a comprehensive private pensions scheme, as well as broaden its support to nationwide health and unemployment insurance. Recent passage of an RMB850 billion three-year medical reform plan is an encouraging, but small, step in that direction.

The bottom line for China: Its unbalanced economy must be rebalanced. The export-led growth formula, which served the nation well for three decades, must now give way to the internal impetus of consumer-led growth. For China, the imperatives of such a rebalancing have never been greater. For the rest of Asia – to say nothing of an unbalanced global economy – China's post-crisis economic leadership role hinges importantly on this critical rebalancing

Policy Risks

Needless to say, a weakened economy usually doesn't take kindly to suggestions that it ought to increase the value of its currency. That's especially the case for an export-led Chinese economy, where sequential growth slowed to a virtual standstill in late 2008. With overall economic growth remaining weak in early 2009 and currently running well below the 6-8% zone that China requires to absorb surplus labor and maintain social stability, the pro-cyclical implications of a tighter currency policy would only add to mounting downside risks.

Little wonder that US Treasury Secretary Geithner's recent remarks on currency manipulation were met with an incredulous response in Beijing. While such strident rhetoric hardly implies action, it is worth considering the consequences if the war of words leads to outright trade sanctions. The impacts would be felt immediately in financial markets. Given America's reliance on China's funding of its external deficit – a reliance that can only grow in an era of open-ended trillion dollar budget deficits – the US is in no position to risk reduced Chinese buying of dollar-denominated assets. Yet that is exactly what might occur if a proud but wounded China retaliates to currency-induced trade sanctions imposed by Washington.

Such retaliation could take the form of a China that simply doesn't show up at an upcoming US Treasury auction. That's hardly a trivial consideration for a United States that needs about \$3 billion of capital inflows each business day to fund its current account deficit. If China fails to provide its share of America's external funding, the dollar could plunge and real long term interest rates could rise. A dollar crisis is the very last thing a US in recession needs. But it could happen if the US turns rhetoric into action in the form of imposing sanctions on Chinese trade. In short, Washington is treading on increasingly thin ice in blaming the Chinese currency for America's woes. A post-bubble US economy is suffering from a major shortfall in domestic demand that is unlikely to be remedied by China bashing. Saber-rattling in this climate is both ill-advised and dangerous.

At the same time, it is equally important to underscore what China should not do. First and foremost, Chinese policymakers must not be overly-optimistic in counting on the old external demand model to start working again. A multi-year weakening of the US consumer is tantamount to a global consumption shock that will impart a protracted drag on any export-led economy. As such, the imperatives of Chinese rebalancing have never been greater. It is increasingly urgent that China shift its growth model from one that has been overly reliant on exports to one that draws increased support from private consumption.

Nor should China be tempted to use the currency lever or other subsidies to boost its export sector In an era of rising unemployment and mounting concerns in the developed world over the benefits of globalization, such efforts could be a recipe for anti-China trade sanctions. As previously noted, those actions might then prompt China to

reconsider its role as one of America's most important overseas lenders. And then, as was the case in the 1930s, the race to the bottom could be on.

Wake-Up Call

There has long been a dispute over the English language translation of the Chinese word for crisis. One popular view is that "wēijī" roughly translates into the compound phenomenon of both danger and opportunity. Unfortunately, that meaning – correct or not – has been lost on a world in crisis Today, more than ever, a world in crisis and recession needs to pull together – not push itself apart Globalization and its cross-border connectivity through trade and capital flows leave us with no other choice

The blame game is completely counter-productive in this environment. Those blaming surplus-saving economies such as China for America's unsustainable spending binge ought to be embarrassed. This is a US problem and one that must be addressed at home with a new and disciplined approach to monetary policy, tough regulatory oversight, and more responsible behavior on the part of consumers and businesses, alike. A bubble-dependent economy that lived beyond its means for a dozen years must now accept the reality of having to live within its means – and not holding others accountable for this painful yet necessary adjustment.

Similarly, China needs to accept that the export-led growth formula always had its limits. An unprecedented external demand shock driven by unheard of synchronous recessions throughout the developed world drives this point home with painful clarity. Economic development is not just about producing for others – especially if those "others" are living beyond their means. In the end, export-led growth must eventually give way to the internal demand of a nation's private consumers. China is ready for this transition and must begin the process as soon as possible.

In short, it is high time for an unbalanced world to begin the heavy lifting of global rebalancing. By framing such an adjustment in the context of the United States and China, the verdict is clear: America needs to save more and consume less, while China needs to save less and consume more.

Easier said than done. But a world in crisis can no longer afford to perpetuate an unstable status quo Global rebalancing is not a quick fix – and therefore, is not all that appealing to myopic politicians. But in the end, it is the only way to put the world back on a sustainable growth track. If there is a silver lining to this crisis, it must be in the wake-up call that it sends to politicians and policy makers throughout this unbalanced world.

SECRETARY OF STATE HILLARY RODHAM CLINTON REMARKS TO THE ASIA SOCIETY

NEW YORK CITY FEBRUARY 13, 2009

RELEASE IN FULL

I'm honored to be here with all of you, to be in this magnificent building, and to have the chance to thank you for the Asia Society's work over many decades to strengthen the relationship between America and the people and governments of Asia.

A half century ago, when the Asia Society was founded, the continent was frozen in a Cold War, racked by poverty, and seemingly destined for desolation. Few in or outside of Asia's borders foresaw anything but a future of conflict, occupation, and despair. Today, the countries I will visit are all at peace. Asia is on the cutting edge of many of the world's innovations and trends; it is a contributor to global culture; a global economic power; and a region of vital importance to the United States today and into the future.

Over the past thirty years I've had the privilege of traveling to a very different Asia. Whenever I think back on those visits, it's as if a movie reel of images old and new starts playing in my mind: the elegant temples of Kyoto; the rituals of nomadic life outside Ulan Bator; the intricate handiwork of traditional craftspeople in Chiang Rai; the vibrant markets of Hanoi and Hong Kong and Dacca; the grand hotels of Singapore and Manila; the calligraphers practicing their art in Xian; the historic dress of Seoul; the traditional dances of Jakarta; the strum of the sitar in New Delhi.

And I've seen skyscrapers and factories; urban corridors and high-tech campuses; research facilities and modern hospitals. A continent where, more often than not, the rule of law and free elections have become – or are in the process of becoming -- the norm; where entrepreneurship and innovation have transformed economies into global economic powers.

Asia has influenced world civilization for millennia, as it has our own culture. Our nation is home to 13 million Asian American citizens, and our daily life is enriched by Asian literature and art; music and movies; food, architecture, medicine, science, technology, and values.

Today, it is tempting to focus our attention on the tensions and perils of our interdependence. But I prefer to view our connectedness as an opportunity for dynamic and productive partnerships that can address both the challenges <u>and</u> the promise of this new century.

That's what I want to talk about today: How the United States is committed to a new era of diplomacy and development in which we will use smart power to work with historic allies and emerging nations to find regional and global solutions to common global problems.

As I have said before, America cannot solve the problems of the world alone; and the world can't solve them without America.

At the same time, given the realities of today's world, we can no longer approach our foreign policy solely country to country, or simply by carving the globe into separate regions. With smart power we will seek to build partnerships that transcend traditional geographic and political boundaries.

In the months ahead, I will press for stronger bilateral, regional, and global cooperation and collaboration when I meet with leaders of Europe, Latin America, the Middle East, and Africa, just as I will seek more robust engagement in my discussions with Asian leaders in Tokyo, Jakarta, Seoul, and Beijing next week.

In making my first trip as Secretary of State to Asia, I hope to signal that we also need strong partners across the Pacific, just as we need strong partners across the Atlantic. We are, after all, both a trans-Atlantic and a trans-Pacific power.

Our relationships with each of the countries I'm visiting — and with all of our partners and allies throughout Asia and the Pacific -- are indispensable to our security and prosperity now and into the future.

When we consider the gravest global threats confronting us — financial instability and economic dislocation; terrorism and weapons of mass destruction; food security and health emergencies; climate change and energy vulnerability; stateless criminal cartels and human exploitation—it is clear that these threats do not stop at borders or oceans.

Pandemics threaten school children in Jakarta and Jacksonville. Global financial crises shrink bank accounts in Sapporo and San Francisco. The dangers posed by nuclear proliferation create worries in Wonju as well Washington. And climate change affects the livelihoods of farmers in China's Henan province and in America's Midwest.

These dangers affect us all and we must all play a role in addressing them.

So I leave for Asia ready to deliver a message about America's desire for more rigorous and persistent commitment, engagement, and collaboration. Ready to work with leaders in Asia to resolve the economic crisis that threatens the Pacific as much as any other region. Ready to strengthen our historic partnerships and alliances develop deeper bonds with all nations. Ready to help prevent the proliferation of nuclear weapons in Asia. Ready to expand our combined efforts on 21st century challenges like climate change and clean energy, pandemics, and income inequality.

In the Obama Administration we are also ready to reach beyond ministerial buildings and official meeting halls – as important as those are. We're ready to engage civil society to strengthen the foundations needed to support good governance, free elections and a free press, wider educational opportunities, stronger health care systems, religious tolerance, and human rights.

And we are ready to listen. Actively listening to our partners isn't just a way of demonstrating respect, it can also be a source of ideas to fuel our common efforts. Too often in the recent past, our government has acted reflexively before considering available facts and evidence or hearing the perspectives of others. But President Obama and I are committed to a foreign policy that is neither impulsive nor ideological, one that values what others have to say.

And when we have differences – which we will - we will discuss them frankly and specify those which limit our capacity to cooperate. As part of our dialogues, we will hold ourselves and others accountable as we work to expand human rights and create a world that respects those rights: where Nobel Peace prize winner Aung San Suu Kyi can live freely in her own country; the people of North Korea can freely choose their own leaders; and the Tibetans and all Chinese people can enjoy religious freedom without fear of persecution.

Exercising smart power begins with realistic assessments of the world we inhabit. This obliges us, no less than other nations, to acknowledge our own contributions to the global problems we face.

Let me start with the global financial crisis that hit us first and hit us deeply. Across the United States today, families are losing jobs, their homes, their savings, and their dreams. But this is not our crisis alone. Its repercussions are also being felt in parts of Asia and around the world.

We have recently heard forecasts from South Korea's new finance minister that their economy will shrink by two percent this year, with 200,000 jobs potentially lost. A Chinese government survey of villages last week reported that 20 million of the nation's 130 million migrant workers are unemployed. In Japan, a new analysis predicts a larger economic contraction than previously forecast. Indonesia's exports fell by more than 20 percent in December as growth estimates have fallen And Taiwan's economy reported a record 44 percent drop in exports. Throughout Asia, the demand for durable goods is down.

The global financial crisis requires every nation to look inward for solutions, but none of us can afford to become so introspective that we overlook the critical role that international partnerships must play in stabilizing the world's economy and putting us all back on a path to prosperity. And we cannot respond with a race to erect trade and other barriers; we must remain committed to a system of open and fair trade.

Here at home, our government is working to address the housing crisis and to restore the banking system. Congress is expected to pass a stimulus package that represents the largest government effort in a generation to create jobs and increase incomes. China, Australia, and others in Asia also are responding vigorously. We need multiple engines working together to reignite global growth.

At the G20 meeting in Washington in November, leaders pledged to take actions from adjusting fiscal policy to strengthening domestic regulation. The upcoming G20 meeting in April will provide an opportunity to build on that pledge.

Like the financial crisis, other issues also require bilateral, as well as regional and global approaches.

The United States is committed to maintaining our historic security alliances in Asia and to building on those relationships to counter the complex global threats we face. I'm very pleased that Japan and South Korea this week agreed to joint assistance for reconstruction efforts in Afghanistan and that both countries continue to work with us on global security, especially in combating piracy off the Horn of Africa.

We will need to work together to address the most acute challenge to stability in Northeast Asia – North Korea's nuclear program. The Obama Administration is committed to working through the Six Party Talks, and next week I will discuss with South Korea, Japan, and China how best to get the negotiations back on track. We believe we have an opportunity to move these discussions forward, but it is incumbent upon North Korea to avoid any provocative actions and unhelpful rhetoric toward South Korea.

The North Korean government has committed to abandoning all nuclear weapons and to return, at an early date, to the treaty on the non-proliferation of nuclear weapons. We continue to hold them to those commitments. If North Korea is genuinely prepared to completely and verifiably eliminate their nuclear weapons program, the Obama Administration will be willing to normalize bilateral relations, replace the Peninsula's longstanding armistice agreements with a permanent peace treaty, and assist in meeting the energy and other economic needs of the North Korean people.

On a related matter, we will assure our allies in Japan that we have not forgotten the families of Japanese citizens abducted to North Korea, and I will meet with some of those families in Tokyo next week.

Global solutions are also essential to addressing climate change and the need for clean sources of energy. Climate change is not just an environmental issue, but also a health, economic, and security issue all wrapped into one. The rapid appointment that the President and I made of a United States Special Envoy for Climate Change reflects our seriousness about dealing with this urgent threat, as does the fact that Special Envoy Todd Stern will accompany me to Asia next week.

Our nation has been the largest historic emitter of greenhouse gases and we acknowledge that we must lead efforts to cut harmful emissions and build a lower-carbon economy. But each of the countries I'm visiting also has its own role to play in this effort. I will press the case for clean energy in both Japan and South Korea. And Orville Schell's commentary in TIME magazine this week reminds us that collaboration on clean energy and greater efficiency and offers a real opportunity to deepen the overall U.S.- Chinese relationship.

We will work hard with the Chinese to create partnerships that promote cleaner energy sources, greater energy efficiency, technology transfers that can benefit both countries, and other strategies that simultaneously protect the environment and promote economic growth.

Next week, I'll visit a Clean Thermal Power Plant in Beijing, built with both GE and Chinese technology and an example of the kind of jobcreating, bilateral, public-private collaboration we need.

You may have heard me describe the portfolio of the State Department as including two of our national security's three "Ds" of defense, diplomacy, and development. Each is essential to advancing our interests and our security, yet too often development is regarded as peripheral to our larger foreign policy objectives. That will not be the case in the Obama Administration. We will energetically promote development around the world to expand opportunities that enable citizens on the margins – especially women and children – to fulfill their God-given potential, which we believe will advance our shared security interests.

That much of Asia currently enjoys peace and prosperity today is due in no small part to American efforts over the past half century to support political, economic, security, and educational alliances with various countries. We are proud to have lent American assistance in response to natural disasters, including rebuilding efforts after the Tsunami in Indonesia and the cyclone in Burma. And we commend the Indonesian people and government for settling longstanding civil conflict in Aceh that threatened the country's progress. Similar positive efforts to achieve peace and stability are working in Timor Leste.

Indonesia is one of Asia's most dynamic nations, where human energy and aspiration has led the country to free and fair elections, a free press, a robust civil society, and a prominent role for women in Indonesian government. We will continue to support Indonesia and other countries in the region that are actively promoting our shared values. And we look forward to working with our other partners and friends in the region – allies Thailand and the Philippines, along with Singapore, Malaysia, and Vietnam – to ensure that ASEAN can live up to its charter to demonstrate the region's capacity for leadership on economic, political, human rights, and social issues.

Let me also thank Australia publicly for its leadership and cooperation over decades. While I'm not able to visit Australia on this trip, it remains one of our most trusted allies in the world. As we have all seen in the news, wildfires have devastated the state of Victoria during the past week. President Obama and Prime Minister Rudd have discussed the situation by phone, and we have sent forest fire specialists to help out.

We want our Australian friends to know that we mourn with them over the loss of innocent lives in this tragedy, and remain grateful for all of our work together in the past and what we will do together in the future. Before I close, let me give you a brief run-down of some key issues I will be addressing next week country by country, starting with my first stop in Japan. Our security alliance with Japan - fifty years old next year - has been and must remain unshakeable. In Tokyo, I will sign the Guam International Agreement, which will position our security alliance to meet the challenges of this new era by moving 8,000 American troops from Okinawa to Guam. Japan is also to be commended for taking on a bigger leadership role in addressing the economic crisis in Pakistan, and for working on collaborative efforts to explore space, cure disease, and offer relief to victims of disasters around the world.

As we move forward, we anticipate an even stronger partnership with Japan that helps preserve the peace and stability of Asia and increasingly focuses on global challenges from disaster relief to advancing education for girls in Afghanistan and Pakistan, to alleviating poverty in Africa.

I mentioned earlier some of the areas where we have found fertile ground for cooperation with Indonesia, and I don't need to remind you that our new President is well-known and much admired there. We now have an opportunity for stronger partnerships on education, energy, and food security.

The Indonesian government led by President Yudhoyono [Yoo-dee-oh-no] also has suggested the creation of a Strategic Partnership with the United States. This idea represents a positive approach to areas of common concern, and we are committed to working with Indonesia to pursue a partnership with a concrete agenda.

From Indonesia, I'll go to South Korea, one of our historic allies. The people and government of South Korea are to be admired for making the transition from the static conditions of the past century to the dynamic state they find themselves in today, including the positive role that women are playing in South Korean society.

The United States and South Korea are both committed to expanding trade between our two countries and working together to that end.

As members of the Asia Society, you know how important China is and how a positive, cooperative relationship between our countries is vital to peace and prosperity, not only in the Asia-Pacific region but all around the globe.

Our mutual economic engagement with China was evident during the economic growth of the past two decades; it is equally evident now, in economic hard times and in the array of global challenges we share, from security to climate change to pandemic disease.

Some believe that a China on the rise is, by definition, an adversary. To the contrary, we believe that the United States and China can benefit from and contribute to each other's successes. It is in our interests to work harder to build on areas of common concern and shared opportunity. China has already asserted itself in positive ways as chair of the Six Party Talks and its participation in international peace-keeping efforts. And our two countries will resume mid-level military to military discussions later this month. We also look forward to further improved relations across the Taiwan Strait.

Even with our differences, the United States will remain committed to pursuing a positive and cooperative relationship with China that enables our countries to enjoy a future of peace, progress, and prosperity.



RE: The Protocol Function

RELEASE IN FULL

The Chief of Protocol manages a unique function in the representation of the Administration's international agenda. Rich in history, it is a role that requires a knowledge of the federal government, the Executive Office of the President and the global community.

If nominated and confirmed as Chief of Protocol my experience as a former White House Social. Secretary, prior interaction with the office of protocol and management experience will be engaged to lead a vibrant and effective team in service to the Administration. I look forward to focusing my efforts on building upon the traditional pillars of the Office of Protocol and integrating the office into the 21st century.

Role of Chief of Protocol

The Chief of Protocol (COP) confers with and advises the Executive Office of the President, the Secretary of State and departments and agencies throughout the Government with respect to questions of international protocol. Protocol is the common language through which differing nations establish, maintain and promote relations on formal occasions. The Chief of Protocol supervises the Protocol staff. The COP develops the protocol programs for the Department of State and plans and directs the activities of the Protocol staff. In addition to oversight of the office's administrative and budgetary obligations of State Department activities and Blair House, the COP oversees the Visits, Ceremonial, Outreach and Diplomatic and Consular Divisions.

Visits Division. The Assistant Chief for Visits coordinates visits of Chiefs of State and Heads of Governments invited to the United States by the President, Vice President and the Secretary of State. This position is also considered the liaison between the White House and State Department, assisting with gift selections, foreign press arrangements and delegations. The White House recommended and the State Department appointed Paul Hegarty to this senior post.


Ceremonials Divisions. The Ceremonials Division plans and executes arrangements for official functions at the State Department hosted by high ranking U.S. Government officials as well as organizes programs for certain public events for Diplomatic Corps and supports the Secretary of State's participation in the General Assembly of the United Nations.

Outreach. The Outreach Division functions within the State Department to develop opportunities with the Diplomatic Corp and international organizations to strengthen our diplomatic efforts and magnify the policies of the Secretary of State and The Executive Office. The office intends to use innovative technologies to broaden these efforts.

Diplomatic and Consular Liaison Division. The DLC Division is responsible for activities associated with the accreditation of ambassadors and other diplomatic and consular officers assigned to missions in Washington; oversees the determination of eligibility of diplomatic and consular officers and employees with respect to privileges and immunities and issuance of the appropriate credentials; and handles problems arising in the Department's relations with foreign diplomatic missions.

The Office of Protocol has accompanied the President on travels abroad to assist with matters concerning protocol. Travel logistics and on the ground support for the Principals are the responsibility of the White House Oval Office Operation and Scheduling and Advance Operations. The Protocol Office works collaboratively with the designated White House staff to determine the appropriate protocol representative for international presidential travel. The following positions support the President's travel as appropriate: the protocol advance officer (supports the presidential advance team and serves as a point of contact for the embassy); the gifts officer (supports the appropriate exchange, record and receipt of official gifts); and, the Office of Protocol representative (interface with foreign leaders, U.S. Embassies and protocol offices of the host country). These positions ensure protocol is effectively executed from country to country. Protocol's function is to support the White House and collaborate on the best ways to serve the Executive Office and should be viewed as a resource for the White House team.

Her father Reza Saberi has given an interview to NPR that should be out later today.

I've talked to Channel 4 news today, as has Baqer Moin former head of BBC Persian. We are asking for questions to be tabled in Parliament, and for the government to ask questions in Iran on her behalf.

My blithely optimistic thinking remains that Roxana's nightmare is happening against the backdrop of the most positive shake up of US/Iran relations in 30 years; from talks with former tutors in Tehran this is not the headline most Iranian officials want right now; I remain hopeful that Roxana will be released soon.

Baqer Moin raised the suggestion that Roxana's sentence may be quid pro quo for Iranian diplomats held by the US on esplonage charges in Erbil in Iraq since 2007. I have no clue if this is true, and I've heard nothing direct about this from Tehran. Any light people can shed on this would be gratefully received.



- 2. We want to urge Japan's Prime Minister to write to Ahmadinejad on Roxana's behalf Roxana's mother Akiko is Japanese, and Japan is an important partner for Iran. Austria played a key role on in the release of American Iranian Woodrow Wilson scholar Halch Esfandiari (her mother was Austrian) I don't know if State has seen movement from the Japanese on this case; any help in this direction would be very welcome.
- 3. Monday week (27th April) is Roxana's 32 birthday (out by 401). Henry and I are setting up an email address for birthday messages for Roxana, to reassure her that she has friends around the world. We will use that day to do something sparky in the media for her, though given how fast things are moving, ten days is a long way off.

Taliban claims victory near Islamabad

ISLAMABAD, Pakistan (CNN) -- Taliban militants who implemented Islamic law in Pakistan's violence-plagued Swat Valley last week have now taken control of a neighboring district.

Control of the Buner district brings the Taliban closer to the capital, Islamabad, than they have been since they started their insurgency. Islamabad is 60 miles (96 km) from the district.

"Our strength is in the hundreds," said Moulana Mohammad Khalil, as heavily armed men openly patrolled the roads in pickup trucks, singing Islamic anthems.

The militants had taken control of the area to ensure that Islamic law, or sharia, is properly imposed, Khalil said.

The government called the advance into Buner a breach of a recently-signed peace agreement.

"Now Taliban are violating the peace agreement, and if they continue the government will take strict action and not allow the Taliban to create a parallel government in that area," said Mian Iftikhar, a spokesman for the regional administration in the North West Frontier Province, where Buner is located.

Last week, the Taliban imposed sharia law in Swat Valley as part of a peace deal with the government. Under the Taliban's strict interpretation, the law prevents women from being seen in public without their husbands or fathers.

Earlier this month, the militant movement made forays into Buner and clashed with locals before withdrawing.

Now the Taliban appear to have returned in force -- a move that indicates the recent government concessions may have emboldened the militants to expand their reach.

The Pakistani government appears unable or unwilling to stop the Taliban's steady advance deeper into the territory of this nuclear-armed country.

In the days after the government's April 13 decision to implement sharia law in Swat, pro-Taliban clerics have staged rallies in Swat and Islamabad. They have demanded the imposition of Islamic law across Pakistan and beyond.

Speaking before an audience of tens of thousands in the Swat Valley town of Mingora on Sunday, cleric Sufi Muhammed declared democracy and Pakistan's judicial system "un-Islamic."

A Taliban spokesman in Swat went a step further Tuesday, calling anyone opposed to his strict interpretation of Islam a non-Muslim.

"Let the judges and the lawyers go to Islamic university," Muslim Khan said. After "they learn Islamic rules, Islamic regulation, they can continue to work."

The rise of the Taliban in Swat has alarmed and frightened some members of local civil society there.

"This is a time bomb for the country," said Aftab Alam, the head of the lawyers' association in Swat district.

Meanwhile, in another Taliban-run region called Orakzai, details emerged of militants forcing a small community of Sikhs to pay a jaziya, or "minority tax," of 10.5 million rupees (roughly \$18,000) earlier this month.

Khan said if his vision of an Islamic society is fulfilled in Pakistan, terror mastermind Osama Bin Laden will be welcome to travel and live openly here. "Sure, he's a Muslim, he can go anywhere," Khan said.

Khan added that he would like to see sharia law implemented beyond Pakistan, even in America, a country he knows intimately. For four years, the Taliban spokesman lived in the United States, working as a painter near Boston, Massachusetts.

Kerry: Administration lacks 'real strategy' for handling Pakistan

WASHINGTON — Just back from a visit to Pakistan, Sen. John Kerry says the Obama administration's plan for that volatile country, rolled out last month with great fanfare, "is not a real strategy."

"Pakistan is in a moment of peril," Kerry, the Democratic chairman of the Senate Foreign Relations Committee, said during a session with USA TODAY reporters and editors. "And I believe there is not in place yet an adequate policy or plan to deal with it."

In an interview after the session, Kerry advised the Obama administration to stop using the term "Af-Pak," to describe a

unified strategy for Afghanistan and Pakistan, because "I think it does a disservice to both countries and to the policy. The two governments, he said, are "very sensitive to it" and "don't see the linkage."

Kerry's spokesman, Frederick Jones, said that the presidents of Pakistan and Afghanistan are scheduled to embark on a rare joint visit to the U.S. for meetings in May, and Kerry plans to host them for lunch May 7.

Richard Holbrooke, President Obama's special representative for Afghanistan and Pakistan, has said the United States must have a unified strategy for both countries, which share a mountainous border region that is a hotbed of Taliban and al-Qaeda activity.

Kerry's comments amounted to one of the sharpest appraisals by a Democrat of one of Obama's signature foreign policies. They marked a change from his initial reaction to Obama's announcement of his plan for the region in a speech March 27, when Kerry issued a statement calling it "realistic and bold."

"Obviously the president disagrees with the chairman on this, and the issues he raised are being aggressively worked in the president's new strategy," White House spokesman Tommy Vietor said in an e-mail.

As an example of how he believes counterinsurgency strategy is lacking, Kerry cited the example of a recent Pakistan army operation in Peshawar.

"The army went in, they expended a lot of energy for us, some lives, and you know, nothing came in underneath it — absolutely nothing. So you're going to wind up with a bunch of folks who are going to hate you.

"If the army's going to take the risk of going in there, for God's sake you have the civil component coming in, so you win something for it," Kerry said.

The Massachusetts senator has sponsored a bill that would steer \$1.5 billion a year in aid to Pakistan. He said he opposes language in a companion bill in the House requiring the president to certify that Pakistan does not support terrorists. Pakistanis consider that "insulting," he said.

Later Tuesday evening, Kerry called a reporter to clarify his comments, saying he did not mean to criticize Obama. "I was not blasting the president," he said. "What I'm saying is that the details have not been fleshed out. We're working hand in hand on it."

Kerry praised Obama's stepped-up attacks against insurgents in Pakistan by unmanned U.S. drone aircraft, saying they had driven "bad guys" into Yemen.

"I think it has had a dramatic impact, and I think that is one of the reasons why people are screaming about it," he said, adding that he did not think there has been inordinate civilian casualties.

In other comments, Kerry said:

- He did not recommend Caroline Kennedy to be U.S. ambassador to the Vatican. Kerry believes an abortion-rights supporter should not be in that post, to avoid offending the Holy See.
- "I made no such recommendation," he said, refuting Italian news media reports. "I think that if you're going to have an ambassador who has access to His Holiness ... it is best not to make things difficult from the outset."
- The decision by the International Criminal Court to issue an arrest warrant for Sudan's president had worsened the humanitarian situation in the Darfur region and complicated efforts to resolve the situation.

"The people are worse off since the Indictment than before," he said. "So it complicates things."

HAVANA (AP) — Fidel Castro says that President Barack Obama "misinterpreted" his brother Raul's sentiments toward the United States.

Raul Castro prompted widespread speculation last week that the U.S. and Cuba could be headed toward a thaw in nearly a half-century of chilly relations, when he said Cuban leaders would be willing to discuss "everything" with the U.S., including human rights, freedom of the press and speech, and political prisoners.

Obama responded by saying Washington seeks a new beginning with Cuba but he also said that Cuba should release some political prisoners and reduce official taxes on remittances from the U.S. as a sign of goodwill.

Fidel Castro wrote in an essay on Tuesday that Obama "without a doubt misinterpreted Raul's declarations."

An event in the life of a nation sometimes has deeper significance than what appears on the surface. The accord by which the government all but ceded administrative and judicial control to militants and their Taliban affiliates in Swat is such a development. This has profound implications for the country that have been obscured by the facile discussions on many TV talk shows. It may well mark a turning point in the country's struggle with rising militancy.

The Swat deal signifies several things all at once. First and foremost it represents a retreat for Jinnah's Pakistan. Whatever the apologists of the deal may claim, it is the very antithesis of the vision and ideals inspired by the country's founder, the core of which was a modern, unified Muslim state, not one fragmented along obscurantist and sectarian lines. Several times during and after the struggle for freedom, the Quaid-e-Azam emphatically ruled out anything resembling a throwback to obscurantism or any variant of theocracy. His leadership rested on principle and according to one of his biographers, he preferred "political wilderness to playing to the gallery".

Today the country's erstwhile leaders do not lead but are led by their dubious interpretation of what the "people want" in Swat, an act of monumental self-deception as any climate of 'opinion' created at gunpoint represents coercion, not consent. Rattled by more aggressive actions by militants, the political and security, establishments caved in to the challenge rather than confront it. The Swat deal signalled weakness and bankruptcy on the part of the ruling elite that chose appearement as the pathway to address the country's mounting internal security challenges. While the government showed no leadership or capacity to govern, the country's security institutions failed to protect its citizens, and legislators (save for the MQM) preferred expediency to principle. Can any of these actors claim to have upheld Junah's ideals or legacy?

The agreement forged between the ANP government and Sufi Mohammed, head of the outlawed Tehreek-e-Nıfaz-e-Shariat-e-Mohammadı (TNSM). on February 16

was effected through a presidential edict on April 13, and endorsed by a hastily contrived parliamentary resolution. This followed months of policy chaos, on again, off again peace accords and stop-go military operations, accompanied by rising violence and the virtual collapse of any civil administration in Swat Indeed this backdrop of rudderless, directionless rule at the centre reinforced the state of national disarray and created the conditions for the eventual Swat surrender.

Amidst this policy confusion, political leaders seemed bereft of any vision or the courage needed to steer the country in a clear direction, and preferred instead to strike a Faustian bargain with little regard for the consequences. Just as government figures were portraying the latest financial bailout from the international community as a triumph of its hat in-hand diplomacy. Islamabad was conceding ground to militants in Swat

A combination of factors, including political short-sightedness and expediency, pursuit of narrow agendas and fear of reprisals by militants, has resulted in choosing a course in Swat that will have serious ramifications for the country. This indicates, above all, a loss of nerve and will by the political and military leadership that seems to have convinced itself that it can contain militancy by conceding to it. But it has set the dangerous precedent of state power surrendering to a local militant force on the dubious premise of 'peace at any price'.

Advocates of the deal in and outside the government marshal a number of arguments to justify it. A major rationale adduced for the Nizam-e-Adl Regulation is that it is no different from the agreements reached in 1994 and 1999 by the Benazir Bhutto and Nawaz Sharif governments and is sanctioned by the special status enjoyed by the Provincially Administered Tribal Areas in the constitution The verdicts of Qazi courts provided in the Adl Regulation will in any case be subject to appeal in the High and Supreme Courts and so will ultimately be consistent with the laws in the rest of the country.

Moreover, it is argued, that the regulation is in consonance with the wishes of the people of Swat who want the restoration of peace above all else. Trading a form of Sharia justice in return for peace is not being hily-livered but pragmatic. As the NWFP governor and assorted ANP leaders have declared, this regulation was "the only way to bring peace." The deal in fact aims to separate the moderates from the militant Taliban.

These claims ignore the political context in which the deal has been forged, with whom and on what terms. Invoking the parallels of 1994 and 1999 is spurious logic as 2009 represents a vastly transformed environment in which the militants entrenched in Swat are affiliated with the Tehreek-e-Taliban Pakistan (TTP) which, officials themselves say, poses a threat to the country's security. How this agreement de-couples Sufi Mohammed's TNSM from these allies no one has cared to explain. It is the TTP militants who hold sway behind the figure of Sufi Mohammed, who was the mediator between the government and the Swat Taliban.

Nor does the argument hold up that the system instituted in Swat will be consistent with Pakistan's constitution. The fig leaf of the state's writ overseeing the Nizam-e-Adl implementation has already been ripped apart by Sufi Mohammed who announced last Sunday that the decisions of the Qazi courts will be final and not subject to appeal in the High and Supreme Courts which he denounced along with the constitution and democracy as un-Islamic. He also declared that judges to the Qazi courts will be appointed with the consent of his organisation. This has thrown into sharp relief the reality of a parallel law being established

The argument trotted out about Swat's 'special status' overlooks the fact that modern statehood requires that laws are unified whereas the regulation fragments the system of law and justice. And as the people who will administer the new regulation are no experts in Muslim jurisprudence or even theology, this cannot even be considered a move toward Islamisation. It is little more than surrender to a medieval form of obscurantism practised by the Taliban

As for the rather nch claim that the regulation has been promulgated in deference to the popular will in Swat, this confuses coercion with consent. If the men of violence are able to create a climate of fear and intimidation and the army too fails to come to the people's rescue, local inhabitants will obviously want a cessation of violence But this is fundamentally different from people becoming instant converts to the worldview espoused by the TNSM and the Taliban

Fow will take issue with a peace agreement if it is forged with those prepared to renounce violence and predicated on an explicit acceptance of the writ of the state. The Swat deal doesn't meet this criterion. Negotiated in haste and under duress, the agreement has not been accompanied by any explanation as to the obligations agreed to by the TNSM, much less about how these will be enforced. Even an undertaking of decommissioning weapons is shrouded in mystery, contrary to official claims that the TNSM will ask its Taliban allies to surrender their arms.

The Swat deal marks a dangerous precedent for several reasons. One, it sets up a parallel justice system that has been 'won' in the shadow of the gun. One-third of NWFP, which the Malakand division represents, has been placed under this parallel law. Two, it cedes space to the militants who wreaked violence, killed at will, burnt girls' schools and spread maybem that led to the exodus of tens of thousands of people from the valley Virtually handing over Swat in this backdrop is tantamount to the state acceding to a form of Taliban warlordism. Far from halting creeping Talibanisation, Islamabad's concession has unintentionally conferred legitimacy to their agenda.

Three, it serves to embolden militant forces to advance further and beyond Swat. Already Sufi Mohammed has vowed to spread the system he calls the 'sharia' to the surrounding region and the rest of the country. The demonstration effect is also evident in the call given by the recently released cleric of Lal Masjid, Maulana Abdul Aziz, for the Swat success to be replicated in all of Pakistan. What is to stop a small band of militants from seizing territory, coercing the inhabitants and holding them to ransom until their cries for peace are responded to by Islamabad with another dose of 'pragmatism' and deference to public wishes? And four, the Swat experiment risks stoking sectaman tensions which will have further deleterious effects on the social fabric and the hody politic

Finally it is worth recounting what an Afghan friend once told me as she recalled her country's experience: "They don't have to seize the capital to take over the country" The sense of distance and complacency that is bred by the atmosphere of power and privilege in Islamahad should not blind the government to the looming threat of militancy which its own missteps have heightened.


