While processing your Freedom of Information Act (FOIA) request dated April 21, 2014 for records concerning meetings and/or communications between the Department of Justice Criminal Division Public Integrity Section and the Internal Revenue Service Tax Exempt and Government Entities Division, the White House, Members of Congress and/or congressional staff, and any non-government entity, regarding 501(c)(4) or other tax-exempt organizations, the Criminal Division (CRM) referred seventy-three pages of material to this Office for processing and direct response to you on behalf of the Office of Legislative Affairs. The CRM administrative tracking number associated with this request is CRM-3000444674. For your information, the documents were received by this Office on July 22, 2015.

I have determined that seventy pages of the material referred by CRM are appropriate for release with excisions made pursuant to Exemptions 5, 6, and 7(C) of the FOIA, 5 U.S.C. § 552(b)(5), (6), and (7)(C), and copies are enclosed. Exemption 5 pertains to certain interand intra-agency communications protected by the deliberative process privilege. Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. Exemption 7(C) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties. In addition, some portions of material are non-responsive to your request and were excised accordingly, as noted on the documents.

Finally, I have determined that the remaining three pages referred by CRM, consisting of drafts, should be withheld in full pursuant to Exemption 5 of the FOIA.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2012). This response is limited to those records that are subject to the requirements of the

FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

Although I am aware that your request is the subject of ongoing litigation and that appeals are not ordinarily acted on in such situations, I am required by statute and regulation to inform you of your right to file an administrative appeal.

DISCLOSE Advocates Renew Fight

The Democrat-authored campaign finance transparency bill known as the DISCLOSE Act failed to win approval in either the 111th or the 112th Congresses, but its backers have set out to try again in this session.

Rep. Chris Van Hollen, D-Md., reintroduced the legislation on Thursday, calling the bill "a first step to clean up the secret money in politics." The bill is unchanged from last year's version; it would require all corporations, unions and super PACs to report campaign expenditures of \$10,000 or more. The bill also covers financial transfers to groups that use the money for election-related activity.

At the outset of the 113th Congress, the legislation's prospects appear no better than they were previously.

The Supreme Court's 2010 Citizens United v. Federal Election Commission ruling ushered in a wave of unrestricted spending that hit the \$6 billion mark in the recent elections, including more than \$1 billion by super PACs and politically active nonprofits that do not always disclose their donors. Van Hollen is engaged in ongoing litigation aimed at forcing the FEC to write stricter disclosure regulations.

"The Supreme Court's decision in Citizens United opened the floodgates to unrestricted special interest spending in American elections and threatens the very nature of our democracy — the unprecedented secret spending during the last elections makes the need for this legislation even more important," Van Hollen said in a statement.

The DISCLOSE Act's lead Senate sponsor in the previous Congress was Rhode Island Democrat Sheldon Whitehouse, who vowed last year to keep pressing ahead despite unanimous GOP Senate opposition. The bill's backers on and off Capitol Hill have voiced optimism that some in the GOP may now come around to support the bill, following an election that saw outside groups outspend parties and candidates in some key congressional races.

At least one GOP senator has already signaled support for some form of disclosure fix. Sens. Lisa Murkowski, R-Alaska, and Ron Wyden, D-Ore., recently unveiled a bipartisan disclosure proposal that they plan to introduce early in this Congress, following a public comment period slated to end in mid-January. However, Senate Minority Leader Mitch McConnell, R-Ky., remains strongly opposed to stricter rules, including the DISCLOSE Act, which he has characterized as an assault on free speech.



The bill is unchanged from last year's version; it would require all corporations, unions and super PACs to report campaign expenditures of \$10,000 or more. The bill also covers financial transfers to groups that use the money for election-related activity.

At the outset of the 113th Congress, the legislation's prospects appear no better than they were previously.

The Supreme Court's 2010 Citizens United v. Federal Election Commission ruling ushered in a wave of unrestricted spending that hit the \$6 billion mark in the recent elections, including more than \$1 billion by super PACs and politically active nonprofits that do not always disclose their donors. Van Hollen is engaged in ongoing litigation aimed at forcing the FEC to write stricter disclosure regulations.

#### American Future Fund

\*It its 2008 application for tax exempt status, the right-wing organization American Future Fund, closely associated with Iowa GOP operatives, stated that it would not be involved in elections.[1] In response to Question 15 of Part II of Form 1024, asking whether the organization "plan[s] to spend any money attempting to influence the selection, nomination, election or appointment of a person to" public office, AFF answered "no." In response to Question 1 of Part II, asking for "detailed narrative description of all activities" past and planned, AFF indicated it would spend 70% of its resources on educating the public, and 30% on influencing legislation.[2] In a follow up letter to the IRS, AFF indicated that its main mission would be "to encourage the adoption of free market policies."[3]

\*However, the same day it sent in its application, American Future Fund issued an ad entitled "Independent," in support of Sen. Norm Coleman, who was up for reelection later that year.[4] The ad praised Sen. Coleman for "working with Republicans and Democrats" and being "an independent voice for Minnesota," and ended with a request to "thank him for his agenda for Minnesota."[5]

\*AFF spent over \$7.3 million on independent expenditures and \$2.2 million on electioneering communications during the 2010 elections.[6] Nearly all of the funding went to ad attacking democrats.

\*The organization spent over \$24 million on independent expenditures and \$66,000 in electioneering communications in 2012.[7]

\*The group has also received donations from other 501(c)(4)s, including over \$11 million from the Center to Protect Patients' Rights,[8] which has no website or address but gave out \$44 million in 2011. [9]

Crossroads GPS

- \*Crossroads GPS, the 501(c)(4) counterpart to the American Crossroads super PAC founded by GOP operatives Karl Rove and Ed Gillespie in 2010 stated on its Form 1024 application for tax exempt recognition that it intended to divide its activities as follows: 20% research, 50% education, and 30% influencing policymaking.[10] In response to Question 15, whether money would be spent to influence politics, Crossroads GPS answered yes, indicating it "may . . . distribute independent political communications, but that "[a]ny such activity will be limited in amount, and will not constitute the organization's primary purpose."
- \*Crossroads GPS spent over \$15 million in independent expenditures in the 2010 elections, running ads against 14 Democratic congressional candidates and for 2 Republican candidates.[11]
- \*In 2012, Crossroads GPS spent over \$70 million on independent expenditures, and over \$200,000 in electioneering communications.[12]

#### Americans for Responsible Leadership

- \*Americans for Responsible Leadership, a conservative organization claiming 501(c)(4) status, responded to Question 15 of Part II in its Form 1024 application submitted on September 14, 2012, by stating that it would not spend money to influence elections.[13]
- \*ARL spent over \$9 million on independent expenditures in the 2012 elections, including more than \$5 million to support Gov. Mitt Romney.[14]
- \*ARL claims to have submitted an amended application that would have reflected the spending.[15]

#### Freedom Path

- \*Freedom Path is a conservative 501(c)(4) group with ties to Republican Senator Orrin Hatch[16] responded to Question 15 of Part II in its Form 1024 application by stating that it would not spend money to influence elections.
- \*Freedom Path spent over \$300,000 in independent expenditures and \$156,000 in electioneering communications in 2012, mostly directed against Dan Liljenquist, who as challenging Sen. Hatch in the Republican primary.[17]

#### RightChange.com II

\*RightChange.com II, the 501(c)(4) counterpart to the conservative 527 RightChange.com, responded to Question 15 of Part II in its Form 1024 application by stating that it would not spend money to

influence elections.[18]

Updates:

1) IRS/Treasury is still considering whether to send a witness to the upcoming hearing. I understand IRS is continuing to discuss the possibility with Sen. Whitehouse's staff. I expect to hear very shortly of the IRS's decision;



- 3) Mythili's testimony was cleared by ODAG and was sent to OMB yesterday morning;
- 4) I have been reaching out to Minority and Minority staff on the committee to determine whether their Senators have any particular questions or concerns that they plan to raise at the hearing. So far, I haven't heard much back from staff. Unfortunately, Senators and their staff often don't concentrate on an upcoming hearing until a few days before the hearing. Also, it doesn't help that Congress is on recess this week. I will continue to reach out to staff this week;

#### Oral Statement:

5) Now that Mythili's written testimony is with OMB, it probably makes sense for CRIM to start drafting Mythili's oral statement. Mythili will have 5 minutes to give her opening statement. The general rule for getting an oral statement within 5 minutes is that it must be no more than 4.5 pgs, dbl spaced, 14pt font-times new roman. Also, the oral statement must stay within the "four corners" of the cleared written statement.

#### Hearing Procedures:

Mythili, will have 5 minutes for her opening statement, and then senators will ask questions in rounds that will likely be 7 minutes each. Senator questioning will be in order of seniority, as modified by the "early bird rule," whereby senators arriving early will have priority. Turn out among members for subcommittee hearings is typically pretty low, although there's no guarantee of this.







Hi Bill,

Thanks for the message. I see your point, but while part of Sen. Whitehouse's interest is focused on certain conduct by 501(c)(4) groups, I don't think that we could really say that for the purposes of this hearing that interest extends to oversight and regulation of these groups, or the regulatory scheme surrounding these groups.

For the purpose of this hearing, Sen. Whitehouse's interest in 501(c)(4) groups is narrowly focused on criminal enforcement of potential material misstatements made under penalty of perjury. He is specifically interested in learning more about the Department of Justice's approach to these cases, as he is for the variety of non-tax issues that we've also discussed. By contrast, Sen. Whitehouse would not ask Ms. Raman about, for instance, what the appropriate limitations are on political spending by 501 (c)(4) groups.

Since Sen. Whitehouse isn't planning to seek justifications for or explanations of the framework governing 501(c)(4) groups from a government witness, and since the majority of the issues that he's interested in don't relate to taxes or the IRS at all, we're not inclined to invite a Treasury Dept. witness to the hearing at this point. In part, we wouldn't want to have to deal with potential committee jurisdictional issues when IRS/Treasury issues aren't the main focus of the hearing. Hopefully this isn't a problem for you, but we're happy to work through any concerns you may have.



Subject: Hearing on Campaign Finance Investigation

Hi Bill,

It was good talking with you yesterday. As we discussed, Sen. Whitehouse would like to convene a subcommittee hearing to look into issues surrounding investigation and prosecution of criminal campaign finance violations by outside groups following Citizens United, and would like to invite a witness from DoJ to testify on the Department's approach to these kinds of potential violations, and to any barriers to effective investigation or prosecution. As I mentioned when we spoke, we have not yet set a hearing date with Chairman Leahy's office, but we are hopeful that we will be able to schedule something for this work period, most likely the week of Mar. 18.

The scope of the hearing will be similar to that for the very helpful briefing that you recently organized for us. Sen. Whitehouse would like to focus on the activities of groups attempting to influence elections through independent expenditures and electioneering communications. Some of the potential violations that he most interested in learning about the investigation of include:

- 1. Knowing and willful violations of FECA prohibitions on coordination between independent organizations and candidates or parties. 2 U.S.C. § 441a(a).
- 2. Knowing and willful violations of disclosure rules, such as prohibitions on contributing money in the name of another person. 2 U.S.C. § 441f.
- 3. Knowing and willful violations of prohibitions on political expenditures by foreign nationals, or the acceptance of funds from foreign nationals to be spent to influence federal elections. 2 U.S.C. § 441e.
- 4. Material false statements to the IRS regarding political activity in order to obtain and maintain 501(c) (4) status. 26 U.S.C. § 7206.

The overarching context here is that with unprecedented amounts of money being raised and spent to influence elections in the wake of Citizens United, and particularly being raised and spent by outside groups like super PACs and 501(c)(4) groups, which are less tightly regulated than candidates, parties, and conventional PACs, Sen. Whitehouse wants to make sure that the Department is able to effectively investigate, and when necessary, prosecute, the conduct of these groups.

With all of the public accounts about, for instance, shell companies being used to hide donor identities, or groups apparently misrepresenting their activities to the IRS, it would be helpful to know how the Department approaches these cases.

It would be particularly helpful if the witness could convey some of the points that came across in the briefing. One point that particularly resonated during the briefing was that the lack of disclosure in the fundraising of these groups makes it difficult to "follow the money" in the context of conduit transfer cases and foreign donation cases. Other issues raised that would be relevant include, for instance, that coordination cases can be challenging to prosecute because the coordination statute is not as clear as it might be; the high bar posed by knowing and willful standards; and privacy considerations when bringing a tax enforcement case. These are just some initial thoughts. We look forward to having a dialogue about what your people think would be informative and appropriate.

I hope this is helpful as you begin to make inquiries, and let's stay in touch as we both develop more information going forward.
