STATEMENT AS TO CAUSE OF ACCIDENT/INCIDENT

EVENT #170402677 IN SUMMARY, R/O RODRIGUEZ BEAT NUMBER 3003 RESPONDED TO GATE C3 FOR 2 INDIVIDUALS REFUSING TO DEBOARD UA FLIGHT 3411. UPON ARRIVAL R/O CAME INTO CONTACT WITH A UNITED AIRLINES SUPERVISOR MS. [REDACTED] MS. [REDACTED] EXPLAINED THAT THERE WAS 1 INDIVIDUAL, MR. DAVID DAO WHO WAS YELLING ABOUT LEAVING THE AIRCRAFT. R/O WAS ESCORTED BY MS. [REDACTED] TO WHERE MR. DAO WAS SITTING. R/O MADE CONTACT WITH THE SUBJECT AND TRIED TO PERSUADE MR. DAO TO LEAVE IN A CALM MANNER. MR DAO STATED, "I'M NOT LEAVING THIS FLIGHT THAT I PAID MONEY FOR. I DON'T CARE IF I GET ARRESTED". AFTER SEVERAL MINUTES OF TRYING TO PERSUADE MR. DAO TO LEAVE THE FLIGHT, OFC. SMITH BEAT NUMBER 3012 ARRIVED ON SCENE AND ADVISED MR. DAO TO LEAVE THE FLIGHT, BUT THE SUBJECT REFUSED TO GET OFF HIS SEAT. AFTER SEVERAL ATTEMPTS FROM R/O RODRIGUEZ AND OFC. SMITH, OFC. LONG BEAT NUMBER 3022 CAME ON SCENE AND IDENTIFIED HIMSELF AS AN OFFICER AND REPEATEDLY ASKED THE SUBJECT TO REMOVE HIMSELF FROM THE AIRCRAFT.

STATEMENT AS TO CAUSE OF ACCIDENT/INCIDENT

CONT... THE SUBJECT RESPONDED REPEATEDLY IN AN AGGRESSIVE MANNER, "I'M NOT GETTING OFF". OFC. LONG ATTEMPTED TO ASSIST THE SUBJECT OFF HIS SEAT WITH TWO HANDS, BUT THE SUBJECT STARTED SWINGING HIS ARMS UP AND DOWN FAST AND VIOLENTLY. OFC. LONG WAS ABLE TO GRAB HOLD OF THE SUBJECT AND PULL HIM FROM THE SEAT TOWARDS THE AISLE. THE SUBJECT THEN STARTED FLAILING HIS ARMS AND STARTED TO FIGHT WITH OFC. LONG. DUE TO THIS INCIDENT, THE SUBJECT WAS ABLE TO KNOCK OFC. LONG'S RIGHT HAND OFF THE SUBJECT'S ARM CAUSING OFC. LONG TO LOSE CONTROL OF MR. DAO. CONSEQUENTIALLY, THE SUBJECT FELL AND HIT HIS MOUTH ON THE ARMREST ACROSS FROM HIM WHICH CAUSED AN INJURY TO HIS MOUTH. OFC. LONG REGAINED CONTROL OF THE SUBJECT AND HE WAS REMOVED FROM THE AIRCRAFT AND BROUGHT TO THE JETBRIDGE. THE SUBJECT LAYED DOWN ON THE DECK AND CLAIMED TO BE A DIABETIC. SUBJECT WAS CONSCIOUS AND BREATHING. CPD 7212 AND 7210 ARRIVED ON SCENE AND WERE BRIEFED OF THE INCIDENT. 3005 ARRIVED ON SCENE REQUESTING EMS.

STATEMENT AS TO CAUSE OF ACCIDENT/INCIDENT

CONT... THE SUBJECT THEN GOT UP AND RAN PAST 7212 BACK ONTO THE AIRCRAFT INTO THE GALLEY OF THE PLANE. UNITS 7212 AND 3003 PURSUED THE SUBJECT AND UPON CONTACT, THE SUBJECT WAS HANGING ONTO A POLE IN THE AIRCRAFT. SUBJECT STATED, "IM NOT GETTING OFF THE PLANE. JUST KILL ME. I WANT TO GO HOME." CFD AMBULANCE 16 CAME ON SCENE AND PERSUADED THE SUBJECT TO BE TREATED. AT WHICH POINT, HE WILLINGLY SAT ON THE STRETCHER AND WAS PLACED INTO AMBULANCE 16 TO BE TRANSPORTED TO LUTHERAN GENERAL HOSPITAL.

This statement is not being given voluntarily, but under duress. I am only giving this statement at this time because I know that I could lose my job if I refuse the direct order being giving to me. This " TO/FROM " report should not be considered a verbatim statement but only a summary of requested information.

In summary : on April 9th 2017 R.O. Smith 3012 was dispatched to disturbance on aircraft in terminal one C-3. Upon arriving on the scene R.O. Smith saw P.O. Rodriguez ask the passenger to leave the plane, but the passenger refused to leave. R.O. Smith also began to ask the passenger to leave as well but he continued to refuse. At this time P.O. Long arrived on the scene and asked the passenger several times to leave but he refused, During this time P.O. Long removed the passenger out of the seat, then P.O. Rodriguez and R.O. Smith assisted P.O. Long as he removed the passenger off the aircraft . At this time CPD and CFD arrived on the scene then moments later the passenger ran back onto the aircraft. During this time R.O. Smith conducted crowd control. No further information to report.

THIS "TO/FROM" REPORT SHOULD NOT BE CONSIDERED A VERBATIM STATEMENT, BUT ONLY A SUMMARY OF REQUESTED INFORMATION.

IN SUMMARY, ON APRIL 9TH 2017 R/O RODRIGUEZ BEAT # 3003 RESPONDED TO A DISTURBANCE AT C3 ON UNITED AIRLINE FLIGHT 3411. UPON ARRIVAL R/O WAS ADVISED BY THE SUPERVISING AGENT OF UNITED AIRLINES THAT THERE WAS A GUEST WHO REFUSED TO LEAVE HIS SEAT. UPON CONTACT WITH THE SUBJECT R/O ADVISED AND TRIED TO PERSUE THE SUBJECT TO LEAVE HIS SEAT. THE SUBJECT REFUSED. OFC. SMITH BEAT #3012 ARRIVED AND ALSO TRIED TO PERSUE AND ADVISE THE SUBJECT TO LEAVE HIS SEAT. OFC. LONG BEAT # 3022 CAME ON SEEN AND ALSO ADVISED THE SUBJECT TO LEAVE. AFTER SEVERAL FAILED ATTEMPTS ON TRYING TO REMOVE THE SUBJECT, OFC. LONG ASSISTED THE SUBJECT BY USING MINIMAL BUT NECCESARY FORCE TO REMOVE THE SUBJECT. SEE ACCIDENT INCIDENT REPORT # 170402677

OFC LONG, 3022 RESPONDED AS BACKUP TO 3003 REGARDING A 2 PERSON DISTURBANCE FOR A REFUSAL TO LEAVE THE AIRCRAFT. AFTER GETTING ON THE SCENE, RO LONG SAW 3003 AND 3012 TALKING TO THE SUBJECT. OFC LONG THEN ANNOUNCED THAT HE IS AN OFFICER AND JOINED IN TRYING TO GET THE SUBJECT TO EXIT THE AIRCRAFT. THE SUBJECT CONTINUED TO REFUSED TO LEAVE AND SAID, I'M NOT LEAVING AND FOLDED HIS ARMS TIGHTLY. OFC LONG ASKED THE OTHER OFFICERS TO ASSIST IN REMOVING THE SUBJECT. WHEN OFC LONG TRIED TO REACH OUT TO HOLD THE SUBJECT, THE SUBJECT STARTED SWINGING HIS ARMS UP AND DOWN WITH A CLOSED FIST. OFC LONG WAS ABLE TO GRAB THE SUBJECT AND PULL HIM AWAY FROM THE WINDOW SEAT TOWARDS THE AISLE. BUT SUDDENLY, THE SUBJECT STARTED FLAILING AND FIGHTING. CONSEQUENTLY, THE SUBJECT WAS ABLE TO KNOCKED THE RIGHT HAND OF OFC LONG OFF OF HIS ARM AND SHOULDER AREA, WHICH CAUSED THE SUBJECT TO FALL, HIT, AND INJURED HIS MOUTH ON THE ARMREST ON THE OTHER SIDE OF THE AISLE. AT THIS TIME, OFC LONG WAS ABLE TO REGAIN CONTROL OF THE SUBJECT AND WAS ABLE TO REMOVE THE SUBJECT FROM THE AIRCRAFT WITH THE HELP OF 3003. THE SUBJECT WAS BROUGHT OUT TO THE JETBRIDGE AREA. HE WAS LIMP SO THE SUBJECT WAS LAID ON THE FLOOR. HE BEGAN TALKING ABOUT A MINUTE LATER. A FEW MINUTES LATER 7211 CAME ON THE SCENE AND HE WAS BRIEFED BY 3022. THE SUBJECT MENTIONED THAT HE WAS A DIABECTIC. THE EMS WAS CALLED. ABOUT A FEW MINUTES LATER, 7012 CAME ON THE SCENE. THE SUBJECT WAS ASKED IF HE WANTED WATER BY A MALE WORKER FOR THE AIRLINE HE SAID YES AND GOT UP AND RAN PASSED 7012 BACK ONTO THE AIRCRAFT. 7012 AND 3003 PERSUED HIM. THE SUBJECT SAID THEY'LL HAVE TO KILL HIM.

In summary, Reporting Sergeant responded to a disturbance Gate C3 on the aircraft. While en route, R/Sgt heard EMT requested to scene. R/Sgt arrived alongside Ambulance 16. APD units 3002, 3003, 3005, 3012 and 3022 on scene, CPD units 7212 and 7217 on scene. R/Sgt proceeded to aircraft where 3003 was interviewing flight crew members. Passengers in back of aircraft were deplaning and subject causing disturbance was in the galley of the plane. R/Sgt waited for EMT to assess subject and R/Sgt checked on well being of officers at the scene. Subject transported to Lutheran General by CFD Ambulance 16. 3012, 3003, and 3022 ordered to write To/From reports of incident and 3003 ordered to write Accident/Incident report of event. 3099 also at scene and updated of all events. Aircraft was deplaned and cleaned of fluids from the scene. Plane reboarded shortly and took off without further incident. Nothing further at time of this report.

Suspect was told to deplane due to overbooking. He refused supervisors orders. CPD was called to aircraft. One ^{Dept. of Aviation (DOA)} officer responded, passenger immediately told the officer he would not deplane. Officer called for back up, after 2 more ^{DOA} showed up he was forceably removed from the aircraft. He laid in the jetway then some how rushed back onto the aircraft all the way to the aft galley. He held on to the direct view panel arm. He was spitting blood saying 'I'm going home. Just Kill me.' At that point I was told to exit the aircraft by CPD. He was taken off by paramedics.
