Dear Hillary--

Happy New Year! I feel terrible to ask you for help, but I am stuck and have run out of other options on my path to citizenship.

After you initially sponsored me and I became a permanent resident, I have now applied for citizenship in August 2011. At first, the process moved relatively quickly until early October, but now I am waiting for the interview/testing (the oath usually is administered within a month or two after) and there has been no movement. I am told by Citizenship and Immigration (CIS) caseworkers that it may be at least another 8 months before they get to me, making the total time more than a year (they advertize 6 months total turnaround time).

I have been in touch with staff and case workers, but am told that I just have to wait and see. While I thoroughly enjoy my current job, I cannot wait to start my career at either an agency contributing to policy and operations (have had several offers) or at a federal law enforcement agency. Without exception and regardless of my qualifications, these jobs all require U.S. citizenship, precluding me from accepting a job or even applying for these positions. Especially the special agent jobs all have an age restriction which I am getting close to and I do not want to miss that cutoff by waiting for citizenship.

Would you consider helping me by reaching out to DHS Secretary Napolitano or CIS Director Alejandro Mayorkas who reports to her on my behalf? The ask is to simply consider moving up my applications for review ASAP. My application is complete, straight forward and I have nothing to hide.

Again, I am sorry for bothering -- I just want to serve my country in a more involved capacity and don't want to miss any more opportunities to do so. As always, thanks for everything you have done for me.
