The following responses have been composed with the guidance of the District's General Counsel in response to items 1-3 of your public records request associated with tracking number **17/18-12222**. We will continue to provide those records that are available for release as they become available. Feel free to follow-up with any questions or concerns.

Request No. 1: Any and all audio and/or visual recordings recorded on February 14, 2018 by interior and exterior surveillance cameras installed in or on the building which Nikolas Cruz entered on Marjory Stoneman Douglas High School campus and carried out his mass shooting.... The time frame for the requested records is October 1, 2017 to the present.

Response/Exemption(s): Any audio and/or visual recordings recorded by the interior and exterior surveillance cameras referenced in your request are confidential and exempt from disclosure under Section 119.07(1), Florida Statutes, pursuant to Sections 281.301(1) and 119.071(3)(a), Florida Statutes. See also: Central Florida Regional Transportation Authority v. Post-Newsweek Stations, Orlando, Inc., 157 So.3d 401 (Fla. 5th DCA 2015); Florida Attorney General's Opinion 15-06, and 2017 Government in the Sunshine Manual at Section 14, Page 142. Even if Florida law had not caused the requested materials to be confidential and exempt from public inspection, school district representatives have advised that the requested documents are no longer within the school district's possession or control. Law enforcement officials took the requested materials into their custody prior to the school district's receipt of your request and the school district was not permitted to retain a copy of said materials.

Request No. 2: Any and all records related to any planned or executed active shooter training exercises involving Marjory Stoneman Douglas High School.... The time frame for the requested records is October 1, 2017 to the present.

Response/Exemption(s): As regards any records relating to any planned or executed active shooter training exercises, any such records are confidential and exempt from disclosure under Section 119.07(1), Florida Statutes, pursuant to Section 281.301(1), Florida Statutes. As such, that request is respectfully declined.

Request No. 3: Any and all records of communications sent to or from Marjory Stoneman Douglas High School Principal Ty Thompson, including but not limited to memoranda, email communications and text messages, relating to active shooter exercises, Nikolas Cruz, and/or Broward County Sheriff Scott Israel... The time frame for the requested records is October 1, 2017 to the present.

Response/Exemption(s): As regards any records relating to the person other than Principal Thompson named in your request, any such records are education records that are confidential and exempt from public inspection under Section 119.07(1), Florida Statutes, pursuant to Section 1002.221, Florida Statutes, and the Family Educational Rights and Privacy Act (FERPA), 20 U.S.C. Section 1232g, and the federal regulations issued pursuant thereto. As such, that request is respectfully declined. As regards any records relating to active shooter exercises, any such records are confidential and exempt from disclosure under Section 119.07(1), Florida Statutes, pursuant to Section 281.301(1), Florida Statutes. As such, that request is respectfully declined. As regards any records sent to or received by Principal Thompson relating

to Broward County Sheriff Scott Israel between 10/01/17 and 03/09/17, the school district will develop an estimate of the cost to retrieve such documents and inspect them for applicable exemptions.

Good afternoon Eagle Families. I have received many emails and phone calls regarding security at MSD. Let me give you an update of what is happening.

We currently have 3 BSO officers and 2 School Board Police patrolling on foot throughout the building during school hours. (all of which are armed, some heavily armed)

We also have our on campus security patrolling hallways and securing exterior gates.

We have limited the amount of student traffic in the hallways during class time.

We also have 4 additional armed BSO deputies that are currently securing the 1200 building; and will remain there for an undisclosed amount of time.

They are also available if an emergency were to arise on campus.

BSO has limited their presence on the gates; as the security has moved inside the campus. We will continue to lockdown the campus prior to 8am, and have only one entrance, front gate until dismissal.

Any parent/visitor must present ID at the front gate; to be allowed access to the front office. Then they must present ID again at the front office to gain access into the building.

We are asking parents NOT to access the campus, for non-essential business.

I spoke with my staff today, and we agreed to start re-introducing curriculum. We realize that many are ready to dive in and get going, we also realize that students are going to adjust at different rates. My staff is aware of that and will make necessary adjustments moving forward.

As I have said all along, there is NO manual for how this works. So please be patient as each student is in a different phase of readiness, as are some of my teachers.


Thank you for all your support as we move through this together.

I am dissatisfied with the consequences implemented.

I spoke with Mr. Thompson, Sheriff Israel, Mr. Runcie. another woman on the board Dr. Ozgood (not sure of the spelling), and Deputy Hanks this past Wednesday to push for what I believe is reasonable and just. Frankly, I do not have much faith or confidence that they will come through or act fast enough since there are only 3 months left of school.

I am a mother of [REDACTED], a middle school teacher, and brain trainer.

The assailant is [REDACTED] who just came to Douglas this year. I would like [REDACTED] security insured by Mr. Thompson, in writing, especially since I have found quite disturbing pictures on the assailant's Facebook page. I am also seeking "proper" consequences and treatment for this assailant along with tracking.

Needless to say since the tragedy on 2/14/18 and the lack of follow through at Douglas that we were promised, I have great concern for [REDACTED] and possibly other students.

All individuals mentioned above, including a private psychologist and Broward County's youth counselor, Dwight Balfour

that I met with this past Thursday evening, agree it needs addressing especially after reviewing the pictures.

Our family has only lived in Parkland for a year and a half, we actually chose this location to allow our [REDACTED], [REDACTED], to attend MSD. We are proud to be part of this community and are happy [REDACTED] will graduate as an Eagle!

I have one question that I was wondering about before the tragedy on February 14th occurred and I now need to know the answer.

Why do the students of MSD not have student ID's? This is the [REDACTED] high school [REDACTED] have attended ([REDACTED]) and in both of these high Schools each student carried a Student ID. These ID's allowed or forbid students access to certain areas at certain times while on the school premises. They documented where students were located in the building at various times amongst, allowed them to pay for school related items and many other things. My neighbor told me that [REDACTED] who attends [REDACTED] [REDACTED] has a student ID and I was told that MSD students use to have ID's, but no longer receive one or need to carry one. Perhaps bringing this to your attention when so many problems need to be addressed all at once would help?

I am attaching a photo I took today when picking up my [REDACTED] at Stoneman Douglas today at 12:46PM. I sat at the front of the school for 10-15 minutes waiting for [REDACTED] to finish up with [REDACTED] meeting regarding their trip that leaves tomorrow. I was watching the officers either looking at their phones one at a time, together or sharing one phone. Given this is the front door and where the kids are entering and exiting I felt that this was unacceptable. I am sure that if it were one officer looking and putting his phone away it would of been in and out however it did not happen this way. I finally was fed up and snapped a photo. I did not sleep last night knowing [REDACTED] was heading back to school today. I have not slept in weeks as I am sure you have not. This is scary to me that these officers feel that whatever is on their phone is more important than our students, than [REDACTED] safety. Please, let me know what we can do to fix this situation. I need the officers that are at the schools to protect our children looking out for dangers not the next post, text, tweet or video.

Yes, this occurred the entire time I was there. It is not just a snip it of time. If it happened the entire time I was there how much more time did it happen? Please, it needs to be fixed.

I sat at the front of the school for 10-15 minutes waiting for [REDACTED] to finish up with [REDACTED] meeting regarding their trip that leaves tomorrow. I was watching the officers either looking at their phones one at a time, together or sharing one phone. Given this is the front door and where the kids are entering and exiting I felt that this was unacceptable. I am sure that if it were one officer looking and putting his phone away it would of been in and out however it did not happen this way. I finally was fed up and snapped a photo. I did not sleep last night knowing [REDACTED] was heading back to school today. I have not slept in weeks as I am sure you have not. This is scary to me that these officers feel that whatever is on their phone is more important than our students, than [REDACTED] safety. Please, let me know what we can do to fix this situation. I need the officers that are at the schools to protect our children looking out for dangers not the next post, text, tweet or video.

Yes, this occurred the entire time I was there. It is not just a snip it of time. If it happened the entire time I was there how much more time did it happen? Please, it needs to be fixed.

I attempted to contact you today. Unfortunately we were not able to speak. I appreciate the efforts that your administrative staff has made in helping my [REDACTED] as it relates to serious problems that have been going on with Ceramics teacher Ms. Traub. Both Ms. Ziccardi and Ms. Figueroa have been a pleasure to work with.

[REDACTED] was moved out of Ms. Traub's class last week due to many issues. Ms. Traub has mistreated and targeted [REDACTED] for months. She may be operating with impunity because she is retiring it does not excuse the learning institution or school district from liability resulting from her behavior. 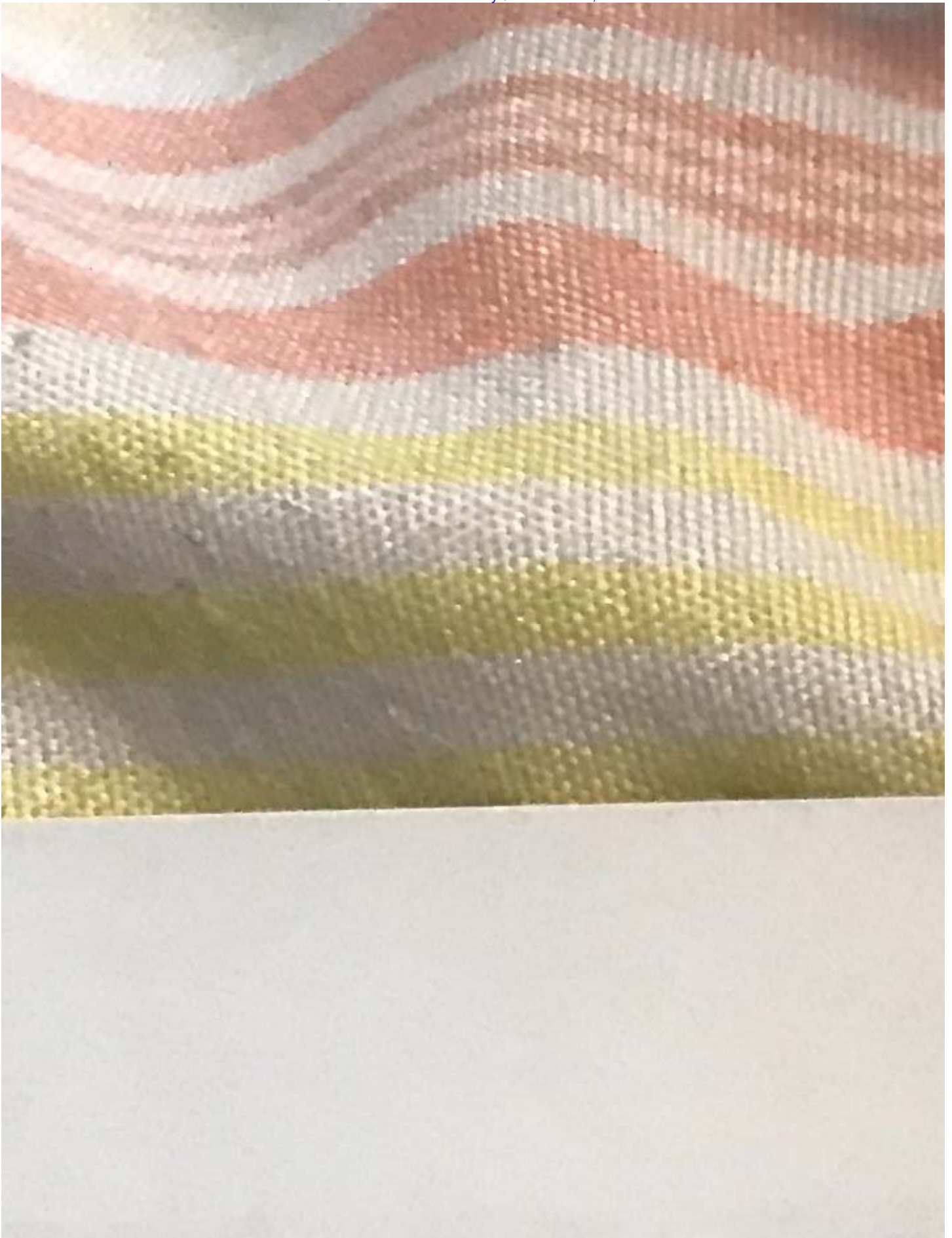
