The enclosed documents Bates stamped FBI 18-CV-00967 -1 through 18-CV-00967 -110 from FOIPA Request Numbers 1374674-000 and 1396901-000 represent the first interim release of information responsive to your requests.

Additionally, the FBI has removed some individual e-mail records as "Other – Non-responsive" because these records were not responsive to your FOIA request.

To minimize costs to you and the FBI, duplicate copies of the same document were not processed.

### **EXPLANATION OF EXEMPTIONS**

## SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;


