This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on May 21, 2018, for information pertaining to all records concerning the use of U.S. Government funds to provide security and/or any other services to President Trump and any companions on their April 28, 2018 visit to Michigan (Date Range for Record Search: From 4/23/2018 To 5/21/2018).

Enclosed are documents responsive to your request. In an effort to provide you with the greatest degree of access authorized by law, we have considered this material under the FOIA statute, Title 5 U.S.C. § 552. Pursuant to this Act, exemptions have been applied where deemed appropriate. The exemptions cited are marked below.

**FREEDOM OF INFORMATION ACT

Provisions of the Freedom of Information Act do not apply to matter that are:
