This FOIA case seeks travel records of and communications between former Federal Bureau of Investigation employees Peter Strzok and Lisa Page. In accordance with the Court's minute order dated April 1, 2019, plaintiff Judicial Watch, Inc. and defendant U.S. Department of Justice report as follows:

- 1. Between March 29 and April 29, 2019, the FBI processed 500 pages of potentially responsive records. In a response sent to Judicial Watch on April 29, 2019, the FBI produced in whole or in part 110 pages of responsive records.
- 2. Between April 29 and May 29, 2019, the FBI processed 500 pages of potentially responsive records. In a response sent to Judicial Watch on May 29, 2019, the FBI produced in whole or in part 31 pages of responsive records.
- 3. Between May 29 and June 28, 2019, the FBI processed 500 pages of potentially responsive records. In a response sent to Judicial Watch on June 28, 2019, the FBI produced in whole or in part 35 pages of responsive records.
- 4. To date, the FBI has processed approximately 6,035 pages of potentially responsive records. Approximately 13,886 pages of potentially responsive records remain to be processed.
