Hey everyone, we of Portland's Liberation just wanted to inform you all of a tip that we received from the area we will be marching to tomorrow. Rose City Antifa and Pacific Northwest Anti-Fascist Workers Collective, two declared Antifascist domestic terrorist organizations located in Portland, have been alerted by the Mayor to our protest against Mayor Ted Wheeler. In preparation for any attack, both of these Antifascist domestic terrorist

groups have posted flyers in the area we plan to be marching in, in an attempt to intimidate and harass the local populace to stay out of their way so they can assault us. We would like to preemptively inform those planning to attend that Antifa does seem to have plans to attack us for protesting against the Mayor. (They should just stay home)
Remember to keep an eye open and let those around you know if/when Rose City Antifa tries to attack. And be sure to be at Ainsworth Elementary tomorrow morning at 11AM! Please ensure you find legal parking on the street, and make sure you lock your doors. We hope to see you then ☐
