Clarification....my assessment is that Michigan is the "hot spot" and has NOT been able to gain staffing resources. Chicago has had an opportunity to work staffing resources for their 500 bed FMS.

The requirements will be competing requirements approved far above the DCE/DCO level. A group is formed called a Unified Control Group (UCG) looking at all staffing requirements from throughout the country to staff the FMSs.
