COMPLAINT

Plaintiff Judicial Watch, Inc. brings this action against Defendant U.S. Department of Health and Human Services to compel compliance with the Freedom of Information Act, 5 U.S.C. § 552. As grounds therefor, Plaintiff alleges as follows:

JURISDICTION AND VENUE

- 1. The Court has jurisdiction over this action pursuant to 5 U.S.C. § 552(a)(4)(B) and 28 U.S.C. § 1331.
 - 2. Venue is proper in this district pursuant to 28 U.S.C. § 1391(e).

PARTIES

3. Judicial Watch, Inc. is a not-for-profit, educational organization incorporated under the laws of the District of Columbia and headquartered at 425 Third Street SW, Suite 800, Washington, DC 20024. Plaintiff seeks to promote transparency, accountability, and integrity in government and fidelity to the rule of law. As part of its mission, Plaintiff regularly requests

records from federal agencies, analyzes the responses it receives, and disseminates its findings to the American public to inform them about "what their government is up to."

4. Defendant U.S. Department of Health and Human Services is an agency of the U.S. Government and is headquartered at 200 Independence Avenue, S.W., Washington, DC 20201. Defendant has possession, custody, and control of records to which Plaintiff seeks access.

STATEMENT OF FACTS

5. On April 19, 2021, Plaintiff submitted an online FOIA request to Defendant seeking access to

Any and all records regarding, concerning, or related to the Department of Health and Human Services' "COVID-19 Community Corps" program, which was announced by the department on April 1, 2021 (please see https://www.hhs.gov/about/news/2021/04/01/hhs-launches-nationwidenetwork-trusted-voices-encourage-vaccination-next-phase-covid-19-publiceducation-campaign.html). This request includes, but is not limited to, the following:

Any and all records depicting the application process and selection criteria for organizations participating in the program.

Any and all records regarding, concerning, or related to the consideration of any organization that sought to be and/or were considered for participation in the program that were not selected.

Any and all records regarding, concerning, or related to any and all awarded or proposed related grants or contracts to or with any organization participating in the program.

Any and all related records of communication between any official, employee, or representative of the Department of Health and Human Services and any officer, employee, or representative of any organization participating in the program.

The timeframe for the request was identified as January 20, 2021 to the present.

- 6. By a letter dated June 11, 2021, Defendant acknowledged receipt of the request on April 19, 2021 and advised Plaintiff that the request had been assigned case number 2021-00933-FOIA-PHS. Defendant's acknowledgement asserted that it was invoking FOIA's 10-day extension of time provision due to "unusual circumstances."
- 7. As of the date of this Complaint, Defendant has failed to: (i) determine whether to comply with the request; (ii) notify Plaintiff of any such determination or the reasons therefor; (iii) advise Plaintiff of the right to appeal any adverse determination; or (iv) produce the requested records or otherwise demonstrate that the requested records are exempt from production.

COUNT I (Violation of FOIA, 5 U.S.C. § 552)

- 8. Plaintiff realleges paragraphs 1 through 7 as if fully stated herein.
- 9. Defendant is in violation of FOIA.
- 10. Plaintiff is being irreparably harmed by Defendant's violation of FOIA, and Plaintiff will continue to be irreparably harmed unless Defendant is compelled to comply with the law.
 - 11. Plaintiff has no adequate remedy at law.
- 12. To trigger FOIA's administrative exhaustion requirement, Defendant was required to make a final determination on Plaintiff's request by June 1, 2021 at the latest.

 Because Defendant failed to make a final determination on Plaintiff's request within the time limits set by FOIA, Plaintiff is deemed to have exhausted its administrative appeal remedies.

WHEREFORE, Plaintiff respectfully requests that the Court: (1) order Defendant to conduct a search for any and all records responsive to Plaintiff's FOIA request and demonstrate that it employed search methods reasonably likely to lead to the discovery of records responsive

to Plaintiff's FOIA request; (2) order Defendant to produce, by a date certain, any and all non-exempt records responsive to Plaintiff's FOIA request and a *Vaughn* index of any responsive records withheld under claim of exemption; (3) enjoin Defendant from continuing to withhold any and all non-exempt records responsive to Plaintiff's FOIA request; (4) grant Plaintiff an award of attorneys' fees and other litigation costs reasonably incurred in this action pursuant to 5 U.S.C. § 552(a)(4)(E); and (5) grant Plaintiff such other relief as the Court deems just and proper.
