**IOC INTELLIGENCE:**

(U//FOUO) According to MPD, as of 0935 hours, there have been approximately 10 arrests ranging from simple assault to weapons possession. IOC is collecting identifiers for the arrestees.

**ACTIVE CROWDS:**

(U//FOUO) As of 0850 hours, USSS indicated there are approximately 10,000 plus in line waiting to go through the Main Magnetometers for the POTUS Ellipse Site at UD Post 215 on Constitution Ave. Some members of the crowd are wearing ballistic helmets, body armor and carrying radio equipment and military grade backpacks. USSS teams will continue to monitor all crowds in the area of the White House zone. No civil disobedience reported at this time.

**GUARDIAN UPDATES:**

(U//FOUO) WFO has approximately 35 Guardian incidents with the #CERTUNREST tag, with 20 of the incidents closed and 15 incidents open or in pre-assessment.

**PENDING TARGETS OR SUBJECTS OF INVESTIGATIVE INTEREST:**

(U//FOUO) Currently, the IOC is monitoring the suspected or reported travel of (b) (6) subjects of interest from various field offices (b) (5), (b) (7)(E) of the subjects were reported as not traveling to the NCR. As of 1000, the IOC had not confirmed the arrival for the rest of these subjects of interest in Washington, DC.

**PLANNED EVENTS:**

(U//FOUO) Per USSS, POTUS is expected to speak at an event on the Ellipse outside the White House at 1100 hours. POTUS is expected to depart the event at approximately 1215 hours.

(U//FOUO) The IOC is tracking the following four planned events in Washington, DC on 6 January 2021:

1. Freedom Rally (10:00am to 4:00pm) – Located at the Capitol.
2. Wild Protest (10:00am to 5:00pm) – Located at Capitol.
3. Jericho March (11:45am to 12:30pm) – Located at the Capitol.
4. Save America Rally (7:00pm) – Located at the Ellipse outside the White House.
