## Military Commissions: ISN 10020 Majid Shoukat Khan Pre-Trial/Pre-Sentencing Hearing Voir Dire of Judge Col. Mark W. Milam July 27, 2021

## Circumstances and Biography:

The Chief Trial Judge of the Military Commissions detailed Judge Col. Mark Milam to the ISN 10020 Majid Shoukat Khan trial process on May 12, 2021. Judge Col. Milam rotated in to replace a judge who retired.

According to his submitted biography,<sup>2</sup> Judge Col. Milam is presently a sitting trial judge for special and general courts martial in the Air Force and the Space Force, specifically for the Eastern Circuit. He has served at various levels of staff judge advocacy around the U.S., but he has also deployed to Saudi Arabia, Germany, Kuwait, and Japan.

At the conclusion of voir dire, neither the government nor the defense found reason to challenge him or request recusal.

## *Voir Dire:*

G: Is the judge currently starting the retirement process, or has he contemplated or spoken about retirement with anybody, to date?	Judge is not eligible to start the retirement process until at least 22SEP2021 and will have at least a year beyond that date before he retires. To date, he has only discussed retirement with his wife.
G: Is the judge familiar with the "In Re: Nashiri III" case?	Judge confessed to not being good with case names and asked if "In Re: Nashiri III" was the case about post-retirement employment of judges. On confirmation, judge stated familiarity.
G: Has the judge sought or is the judge seeking outside employment from the DOD?	No. Judge stated that he intended to become a farmer in Maine. He has applied for a job as a judge or chief judge at an American Indian reservation near his intended settlement. The application is with the Wabanaki tribe.
	In response to clarification questions, the judge stated that he did not think that the tribe was affiliated with the United States Government in any way. He saw the advertisement for the position in the <i>Machias Valley</i> newspaper and put in his resume. He is not aware of the federal government funding the tribe or the tribal

	judiciary, assuming instead that it's the state government, but confessed to not knowing for sure. He has not been contacted for interview.
G: Would anything about the process of applying for the job in Maine hinder the judge's impartiality in this case?	No.
G: Is the judge assigned a legal advisor or clerk?	Yes. Fred Taylor. "He's my lifeline as a legal advisor."
G: Is the judge aware of any applications Taylor has made for outside employment?	No. Per discussions between the judge and Taylor, Taylor intends to stick with the process until some of the cases are complete.
G: Is the judge familiar with the accused?	No.

G: Has the judge read, seen, or reviewed anything about the commission from an extra-judicial source?	Judge looked up one article that described the charges against Khan, or possibly what he pled guilty to doing.

G: Has the judge heard anyone express an opinion about the commission?	No.
G: Is there anything in the judge's review of the article that would impair his ability to be impartial?	No.
G: Has the judge expressed any public opinions about this particular commission?	No. "Not about the commissions at all."
G: Does the judge know any members of the prosecution or defense teams?	No.

Kuwait (2002)?	Judge recalls leaving before hostilities began.
G: What were the judge's duties during that deployment?	Judge was the SJA for the wing, which flew A-10 planes out of the Al-Jaber Air Base.
G: Did the unit that the judge supported suffer any casualties attributed to Al Qa'eda?	No.
G: Did the judge witness or investigate any situations involving terrorism or Al Qa'eda?	No.
G: How long was the judge's deployment to Qatar (2010)?	One year as a PCS.
G: What was the judge's role in Qatar?	Judge was SJA for the wing at Al Udeid Air Base.
G: What was the function of that wing?	The air base was mostly responsible for refueling multiple airframes. Al Udeid Air Base was a hub for flight in the Middle East.
