I just wanted to make you aware of an arrest we made late last night that will likely garner significant media attention.

On Saturday, May 28, 2022, at approximately 2226 hours, we were called to a head-on crash that occurred on SR-29 at Oakville Cross Road. Upon our arrival, we determined the incident to be a non-injury crash involving two vehicles.

The suspected at fault driver was identified as Paul Pelosi, the husband of Nancy Pelosi.

Mr. Pelosi was determined to be under the influence of an alcoholic beverage and arrested at 2344 hours. He refused the PAS and submitted to a blood test, results pending.

We attempted to cite and release him, but he didn't want anyone else to be aware of his arrest. He was medically cleared at the Queen of the Valley Hospital before being booked into NCDC. My unit just finished booking him.

I wanted to make sure you were aware as his arrest will likely generate significant media attention. For now, we aren't releasing any information to the media. They will likely find out soon as our arrest logs are public record and will be released on Tuesday.
