Dear Mr. Marshall:

This is the final response of the Administration for Children and Families to your May 20, 2022, Freedom of Information Act (FOIA) request for all documents related to the preparation and logistics involved in the transportation of Unaccompanied Alien Children (UACs) to and from Chattanooga's Wilson Air Center on May 14, 2021and all ACF officials' internal email communications related to the transportation of UACs to and from Chattanooga's Wilson Air Center on May 14, 2021.

The Administration for Children and Families' Office of Refugee Resettlement (ORR) conducted a thorough search of its files and located the enclosed 16 pages of responsive records.

We reasonably foresee that disclosure would harm an interest protected by one or more of the nine exemptions to the FOIA's general rule of disclosure. Portions of these pages have been withheld in part under the FOIA exemption (b)(6). This exemption permits the withholding of records which, if released, would constitute a clearly unwarranted invasion of personal privacy. In this case, the withheld information consists of personal email addresses, cellphone numbers, dates of birth, and other private information of private individuals. Public disclosure of this information would constitute an invasion of privacy of those individuals whose identifying information was disclosed. In withholding the information, the individual's privacy interest was balanced against any public interest in disclosure. In each instance where information was withheld, it was determined that the individual's privacy interests outweighed any public interest in disclosure of the withheld information. Disclosure of the withheld information would invade the privacy of the subject individuals but would reveal nothing about the operations or activities of the government.




