For this production, DHS reviewed three hundred sixty-six (366) pages of which thirty-three (33) pages were duplicative, two hundred seventy (270) pages were deemed non-responsive, and sixty-three (63) pages were disclosed in part pursuant to FOIA exemption (b)(6).

The sixty-three (63) pages provided are numbered DHS-001-03560-000045 to DHS-001-03560-000107.

Hi, **(b)(6)**

Our team at the Election Integrity Partnership received a report from the Pima County Recorder that a variety of datapoints about voting in Arizona are wrong. I've included the ticket contents from the official below as well as the screenshots with the incorrect information.

I'm not sure what your data source was for you election center, but you might want to do a more aggressive sweep for incorrect data or perhaps disable the feature until you can verify that what you are showing is correct. The number of errors on this one screen is not a good sign.

Our Partnership is working directly with Google, Twitter, Facebook, TikTok, Pinterest, Reddit and other platforms to route reports of election disinformation their way. If you think that there might be more issues, perhaps we can onboard your folks to get alerts when we receive reports from the 8,000 local election officials we are plugged into.

Let me know if you need any more information to fix this. Please let me know when it is handled so I can update the Arizona authorities.





Hoping this message finds you well. As a follow up to our conversations a couple of months back, I wanted to highlight a recent post by the Election Integrity Partnership, which was created in response to a message you sent to the CIS misinformation reporting portal. As CIS and CISA have mentioned, we are working with CIS to provide rapid response capabilities to election officials who report to <u>misinformation@cisecurity.com</u>.

Our writeup, <u>which can be found here</u>, summarizes our findings and the actions which we took. Our researchers (CC'd) found this website purports to be a project associated with Kentuckians for Real Options, an unauthorized campaign committee that is registered with the Kentucky Registry of Election Finance. Overall this site seems to exist as a project of the Charles Booker supporters running Kentuckians for Real Options. It appears that they are attempting to prove that his loss was not legitimate by collecting examples of ballot irregularities. All of this information, as well as the actions which platforms have taken, can be found in the above linked report. You can also find our Tweet thread, <u>here</u>.
