Dear William Marshall:

The Massachusetts Department of State Police ("Department") received your public records request on July 25, 2023, seeking the following information: "All audio/visual recordings (including dispatch calls, police and EMS communications, body-worn and dashcam footage), electronic messages, incident reports, witness statements, investigative reports, medical records and reports, and all other records related to the death of Tafari Campbell on July 23-24, 2023 in the Edgartown Great Pond."

On July 25, 2023, the Department denied your request pursuant to G.L. c. 4, §7, cl. 26 (f), stating that "according to information provided to this office, this incident remains the subject of an ongoing investigation. In light of the pending investigation, the record(s) you seek are not subject to public disclosure at this time pursuant to G.L. c. 4, §7, cl. 26 (f)."

The Department reviewed the Supervisor of Records decision in SPR23/1719. In response to the decision the Department is providing you with the following supplemental response:

Please be advised that at the time of the Department's response, according to information provided to this office, this incident remained the subject of an ongoing investigation by the Cape and Island District Attorney's Office and State Police Detectives Unit. In light of the pending investigation, the record(s) you seek were not subject to public disclosure at the time of the response pursuant to G.L. c. 4, §7, cl. 26 (f), which specifically exempts from public disclosure investigatory materials necessarily compiled out of the public view by law enforcement or other investigatory officials the disclosure of which materials would probably so prejudice the possibility of effective law enforcement that such disclosure would not be in the public interest. See <u>Bougas v. Chief of Police</u>, 371 Mass. 59, 62 (1976). See also, Supervisor of Public Records No.: SPR15/203 (upholding the Department's withholding of records related to an ongoing investigation).

Releasing information and records regarding an on-going investigation, at the time of the response, would detract from effective law enforcement and could prejudice investigative efforts. The

Department was compelled to conduct athoroughy and objective investigation of the events into this incident. There was an interest in preserving the integrity of the investigation and any potential subsequent prosecution if the investigation resulted in criminal charges. It was not in the public's interest to release the information at the time of the response, as such release could potentially taint any potential jury pool if the investigation resulted in a criminal prosecution and dissuade witnesses from speaking freely with police concerning matters under investigation. Therefore, the records you seek were not available at the time of the Department's response pursuant to G.L. c. 4, §7, cl. 26 (f).

The investigation is now complete, and the records are available subject to the public records law. The Department conducted a diligent search of its records and is unable to locate any body worn and cruiser mounted video recordings. The Department is in the process of reviewing responsive records and will supplement this response. At this time, the Department is providing you with Case Report 2023-102-251.

As you will see, the Department has redacted dates of birth, addresses, social security numbers, medical information, and phone number of involved parties pursuant to G. L. c. 4, §7, cl. 26 (c), the privacy exemption. As you know, G.L. c. 4, §7, cl. 26 (c) exempts from public disclosure "personnel and medical files or information; also any other materials or data relating to a specifically named individual, the disclosure of which may constitute an unwarranted invasion of personal privacy." Analysis under the second, privacy clause is subjective in nature and requires a balancing of the public's right to know against the relevant privacy interests at stake. <u>Attorney General v. Assistant Commissioner of the Real Prop. Dept.</u>, 380 Mass. at 625; <u>Torres v. Attorney General</u>, 391 Mass. 1, 9 (1984).

In addition, the Department has also made redactions to information that may be used to directly or indirectly identify potential witnesses pursuant to G.L. c. 4, §7, cl. 26 (f), which exempts from public disclosure investigatory materials necessarily compiled out of the public view by law enforcement or other investigatory officials the disclosure of which materials would probably so prejudice the possibility of effective law enforcement that such disclosure would not be in the public interest. The policy considerations underlying the exemption are well settled. *See Bougas v. Chief of Police*, 371 Mass. 59, 62 (1976)(among them "avoidance of premature disclosure of the Commonwealth's case prior to trial, the prevention of the disclosure of confidential investigative techniques, procedures, or sources of information, the encouragement of individual citizens to come forward and speak freely with police concerning matters under investigation, and the creation of initiative that police officers might be completely candid in recording their observations, hypotheses and interim conclusions"). Here, the Department asserts that the these redactions help encourage individuals to come forward and speak freely with police concerning matters under investigation.

Finally, the Department has also redacted the names of Secret Service Agents pursuant to G.L. c. 4, §7, cl. 26 (n) which exempts records "including but not limited to blueprints, plans, policies, procedures and schematic drawings, which relate to internal layout and structural elements, security measures, emergency preparedness, threat or vulnerability assessments, or any other records relating to the security or safety of persons or buildings, structures, facilities, utilities, transportation or other infrastructure located within the commonwealth, the disclosure of which, in the reasonable judgment of the record custodian, subject to review by the supervisor of public records under subsection (b) of section 10 of chapter 66, is likely to jeopardize public safety." When analyzing the applicability of Exemption (n), the SJC determined that the first prong of this exemption examines "whether, and to what degree, the record sought resembles the records listed as examples in the statute;" specifically, the "inquiry is whether, and to what degree, the record is one a terrorist 'would find useful to maximize damage." The second prong of Exemption (n) examines "the factual and contextual support for the proposition that disclosure of the record is 'likely to jeopardize public safety." Here,

the Department asserts that the release of this information would be used to determine the Secret Service staffing levels, which directly relates to security measures undertaken to protect people and locations used by individuals under State Police Protection. By using this information to determine staffing levels, an individual aiming to do harm could "maximize damage" by tailoring their plans to account for the number of agents assigned to a particular person or location under Secret Service Protection.

If you wish to challenge any aspect of this response, you may appeal to the Supervisor of Public Records following the procedure set forth in 950 C.M.R. 32.08, a copy of which is available at http://www.mass.gov/courts/case-legal-res/law-lib/laws-by-source/cmr/. You may also file a civil action in accordance with M.G.L. c. 66, § 10A.


1. On Sunday, July 23, 2023, at approximately 7:58 PM, I, Trooper Dustin Shaw #4036,
assigned to the Massachusetts State Police-Cape and Islands State Police Detective Unit (SPDU) was
notified by the Dukes County Regional Emergency Communications Center of a possible drowning
incident that originated from a 911 call at in the Town of Edgartown, on
Martha's Vineyard, at 7:46 PM. The 911 caller was identified as
a United States Secret Service Special Agent. I am aware that in
Edgartown is a residence owned by
. I was informed that two (2) people on paddleboards had entered the water at Edgartown
Great Pond, from the shore of and an
being witnessed in distress going under the water and never resurfacing. I was informed that a search
and rescue operation was underway. I contacted Massachusetts State Police-Cape and Islands State
Police Detective Unit Commander, Detective Lieutenant Richard Cosgrove # 2330, and advised him of
the situation. Also notified of the incident were personnel from the Massachusetts State Police-Oak
Bluffs Barracks.
2. At approximately 8:15 PM, I arrived on scene in the area of Edgartown Great Pond and was directed to the Incident Command Post (ICP), located at Wilsons Landing. Wilsons Landing is a dirt parking lot that allows boat access to Edgartown Great Pond. Edgartown Great Pond is an approximate 890-acre, brackish pond, located on the South Shore of Martha's Vineyard. The pond currently did not have open access to the Atlantic Ocean and has a maximum water depth of approximately 10-15 feet in some portions of the pond. Many residential homes abut the shoreline of the pond, and there are several coves and inlets throughout.
Upon my arrival at the ICP, I observed a large fire department, search and rescue, and EMS presence. I began speaking with Edgartown Police Sergeant William Bishop, who informed me that a search and rescue mission was currently underway for a missing paddleboarder in Edgartown Great Pond. Sgt. Bishop informed me that Officers from the Edgartown Police Department were conducting a door to door and shoreline search of the vicinity. Sgt. Bishop directed me to the incident commander, Edgartown Fire (EFD) Chief Alex Schaeffer. I located EFD Chief Schaeffer, and he informed me that two (2) paddleboarders launched two (2) separate paddleboards from the shoreline at in Edgartown. Tafari CAMPBELL (DOB) was identified as the missing paddleboarder, and (DOB) was identified as the surviving paddleboarder. I was informed that CAMPBELL is the personal Chef of and his family, and informed that campatible prior to the incident.
4. EFD Chief Schaeffer went on to explain that CAMPBELL and were paddleboarding together when observed CAMPBELL on the board, in the standing position and suddenly lose his balance and enter the water, and struggle to stay above water. Chief Schaffer informed me that observed CAMPBELL go under the water, and never resurface. reportedly subsequently paddled back to shore to and alerted a member of the U.S. Secret Service at a nearby security post. 

- 37. At approximately 10:15 AM, I contacted the Office of the Chief Medical Examiner (OCME) and reported the death to In-Take Specialist Jennifer Forde. IT-Specialist Forde accepted jurisdiction and provided OCME Case# 2023-10316.
- 38. We transported CAMPBELL'S body back to the ICP at Wilsons Landing and was met by MSP Crime Scene Services Tpr. O'Loughlin. At approximately 10:15 AM myself and DLT Cosgrove rolled CAMPBELLS body and did not observe any trauma or injuries. Tpr. O'Loughlin took all necessary digital photography of CAMPBELL'S body, overall scene, and paddleboards.
- 39. At approximately 10:25 AM, US Secret Service Special Agent, ASAIC positive identification of the body recovered to be that of CAMPBELL. ASAIC , and other members of the USSS confirmed that CAMPBELL'S (), had been notified of his death, and was en route to Martha's Vineyard.
- 40. Arrangements were made through the OCME Operations to transport CAMPBELLS body from the ICP to the US Coast Guard Station Menemsha (Chilmark, MA). From the CG Station Menemsha, travel by USCG vessel to the US Coast Guard Sector Southeastern New England, CG Station Woods Hole, where OCME transport would be waiting to accept CAMPBELLS' body. The decision was made that I would accompany CAMPBELL'S body throughout the entire process until transfer to OCME was complete.




