- I am aware that U.S. Secret Service protection is normally offered to me and is available but, for personal reasons, I wish to decline protection and hereby relieve the Secret Service of the personal security for Natalie Biden and Hunter Biden effective 08/18/16 through 08/22/16.
- I wish protection to resume for Natalie Biden and Hunter Biden upon their return to Washington, D.C. on 08/22.
