(ANA-MPA) -- The wife of US Vice-President Joe Biden, Jill, arrived in Greece on Friday at the head of a US presidential delegation to the 2011 Special Olympics Games, which will commence in Athens on Saturday.

Hours before attending the "Flame of Hope" lighting ceremony at the downtown Athens stadium that hosted the first Olympic Games in 1896, Biden boarded the USS Ramage, a destroyer anchored off the Faliro marina in southern coastal Athens.

"I am looking forward to watching the Games and cheering the athletes," Biden told the assembled crew of the guided missile destroyer.

She was accompanied by visiting US Secretary of the Navy Ray Mabus.

On his part, Mabus, a former Mississippi governor, praised the 279 officers and sailors of the US warship for their role in anti-ballistic missile defence operations in the eastern Mediterranean.

Approximately 7,000 athletes from more than 170 countries around the world, along with their families and thousands of coaches, volunteers and spectators, are expected to attend the Special Olympics Games, the biggest sporting event hosted in the east Mediterranean country since the Athens 2004 Summer Games.



Tony: Tbilisi is still glowing today in the aftermath of the Vice President's visit.

Everyone from President Saakashvili to his most ardent opponents
has hadnothing but good things to say about the visit and the Vice President
personally.

The speech in Parliament followed by the hour long town hall-like meeting with IDP kids had Tbilisi buzzing last night. Both events were carried live and thenrebroadcast several times on all television channels. As happy as people were with the substance of the speech, the Vice President's engagement with the IDP kids touched people's hearts here. No exaggeration. Many people have mentioned to me how moved they were when the Vice President told the IDP kids that he understood what they had gone through, but that his mother always told him good things can come out of bad. They identified very personally when he cited as an example the tragic death of his first wife and daughter in an automobile accident, and the survival and his subsequent joy in raising his two sons.

President Saakashvili was extremely happy with the visit. He told me at the airport that the visit exceeded his most optimistic expectations. He said the speech was truly "historic," and that he and Acting Foreign Minister Bokeria were both receiving calls from people praising the speech. The opposition members who met with the Vice President all came out of their meeting praising the discussion and American support for democracy in Georgia.

If this sounds a bit emotional, well that is because the impact of the visit here has been emotional. I hope you will convey this to the Vice President. Hereally conveyed the message effectively that the Administration supports Georgia's independence and territorial integrity.

Thanks for all that you and the traveling team did to make the visit such a success. All the best. John
