Dear Mayor Pons,

As I'm sure you were aware the 2nd Sunday Festival which is a public event has told Jewish community that we will not be allowed to light a menorah or have a visible presence at the festival on the 10th. The festival said that this is because they did not want to take sides in the Israel/Hamas war. However, organizers of the festival have said that the Jewish community will be allowed to participate should we light the Menorah under a banner calling for a ceasefire which is clearly taking sides in the conflict.

As per the International Holocaust Remeberance Alliance (IHRA)'s, working definition of antisemitism, "Holding all jews collectively responsible for the actions of Isreal" constitutes antisemitism. The Commonwealth of Virginia recognized this definition in HB 1606 which Governor Yongkin signed into law this year. The state department has also acknowledged the definition and the White House issued an executive order accepting it in 2019.

Given that the festival is engaging in what both the Commonwealth of Virginia and the Federal Government define as antisemitism it is inappropriate to allow them to continue. Furthermore using public resources such as the police and permits as well as to shut down city streets would be to using tax dollars to subsidize said discrimination. As such I urge you to pull all publicly funded support including but not limited to any permits, street closures, and police presence at the festival.

My great grandfather fled antisemitic persecution and he chose to settle in Hampton Roads because he was promised that he and his children would be safe and welcome in Southeastern Virginia. It is time for the city of Williamsburg to live up to that promise.

Thank you for your email. We understand the difficult position the vendors are now in because of this situation, and we are empathetic to the decision you now must make for your business. A large number of special events take place in the City of Williamsburg every year that feature local and national artists. A good example is the Christmas Market that is currently underway. While these are private events much like 2nd Sundays and the City is largely unaware of how the vendors are selected, we would encourage you to consider those opportunities as possible solutions to the current dilemma.

In addition, as you have expressed interest in perhaps starting your own event, the City's process begins with a special event permit. A good place to begin your research on launching an event is to review the requirements for the City's special event permits, which you can find in our <u>City Code</u>. The application form is also on our website.

We wish you the best of luck and much success as you pursue further opportunities.
