MOTION FOR DEFAULT JUDGMENT

Plaintiff Judicial Watch, Inc. moves for entry of default judgment against Defendant Fani Willis, in her official capacity as District Attorney of the Atlanta Judicial Circuit. As grounds for this Motion, Plaintiff shows that on March 13, 2024, it filed an affidavit of service upon Defendant.¹ Said Affidavit showed that service was made upon Defendant on March 11, 2024. Defendant has not filed an answer and no answer has been served upon Plaintiff. Pursuant to O.C.G.A. 9-11-12(a), Defendant's answer was due 30 days after service, or on April 10, 2024. Pursuant to O.C.G.A. 9-11-55(a), the case automatically became in default when an answer was not filed by the due date. Further pursuant to that Code section, Defendant was permitted as a matter of right to open the default within 15 days of the day of default, or by April 25, 2024. Further pursuant to that Code section, when Defendant did not exercise her right to open the






