Re: Freedom of Information Act Appeal – File Number 20240871

Dear Mr. Marshall:

I am writing in response to your Freedom of Information Act (FOIA) appeal regarding the above referenced file.

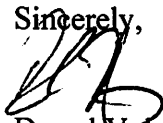
In your FOIA request, you sought any and all records related to incidents of aggression and bites involving the now-deceased Biden family dog, “Champ”, including but not limited to communications sent to and from USSS officials in the Uniformed and Non-Uniformed Divisions involved in White House operations, the Vice Presidential Protective Detail, and the Presidential Protection Division (time period 2008-2021). In response the agency’s FOIA office searched for responsive records and found no records.

On appeal, you challenged the adequacy of the agency’s search. To address your appeal, the agency reviewed the search. An additional search for responsive records was conducted during which responsive records were located. The records responsive to your request have now been reviewed on appeal, and it has been determined that information from these records may be released to you. Copies of the pages containing this information are enclosed. However, some information is being withheld under the FOIA.

The records in question contain information compiled for law enforcement purposes. Under the FOIA, pursuant to Title 5, United States Code, Section 552 (b)(6) and (b)(7)(C), certain information, is being withheld since the disclosure of this information could constitute an unwarranted invasion of privacy. Additionally, some information is being withheld under Section 552 (b)(7)(E) since the disclosure of this information could disclose techniques and procedures for law enforcement investigations or disclose guidelines for law enforcement investigations or prosecutions which could risk circumvention of the law. These exemptions have been applied where deemed appropriate after considering the foreseeable harm standard outlined in the 2016 amendment to 5 U.S.C. § 552 (a)(8)(A)(i) and DOJ guidance.

Under federal law, we are required to advise you that any decision on appeal is subject to judicial review in the District Court in the district where the complainant resides, has a principal place of business, or in which the agency records are situated, or in the District of Columbia.
