Hello Ha, thanks for this reply. Yes I agree that we not respond. I've also spread the word throughout our team and partner clinics, and have provided neutral scripting for front line staff. I've requested that they forward any inquiries that come in to me, and I will then turn them over to [REDACTED]

I have a meeting next week with [REDACTED] to discuss some of the scope of practice/credentialing/clinical policy issues we've discussed. We have an action plan for communications. I think the main area of concern that remains is security and safety. I know we are trying to set up a follow up meeting. Has there been any progress with UCPD or otherwise on this front? A gynecologist at Boston Children's Hospital had her home address found and posted online by right wing groups, and she now has a security detail. A pediatrician at Children's LA had her cell phone number found via a FOIA request for her NIH grant paperwork, it was also posted online.

Also I am including a link to a statement released 2 days ago jointly by USPATH and WPATH. The staffs are still wrapping up from the WPATH conference this weekend, and will post a more formalized version on the website in the coming week or two. We felt it urgent to get the statement out right away.
