1 (Call to Order of the Court at 10:31 a.m.)

2 DEPUTY CLERK: This is Civil Action 25-2623, *Judicial*  
3 *Watch, Inc. versus the United States African Development*  
4 *Foundation.*

5 May I have counsel identify yourselves for the record,  
6 beginning with plaintiff's counsel.

7 MR. O'DONNELL: Good morning, Your Honor. Sean  
8 O'Donnell for Judicial Watch.

9 THE COURT: Good morning.

10 MR. BARDO: Good morning, Your Honor. John Bardo,  
11 Assistant U.S. Attorney on behalf of the government.

12 THE COURT: Good morning.

13 This matter is here for a status hearing. The  
14 government had recommended that the parties meet and consult  
15 and that a joint report be submitted indicating how the parties  
16 wanted to proceed, but apparently the plaintiff disagrees with  
17 that proposal; is that right?

18 MR. O'DONNELL: Yes, Your Honor. This is Sean  
19 O'Donnell with Judicial Watch.

20 THE COURT: What's the basis for the disagreement with  
21 that?

22 MR. O'DONNELL: Thank you, Your Honor. We filed this  
23 FOIA request over six months ago. We sat on our right to sue,  
24 if you will, so we waited -- we filed this complaint 170 days  
25 ago. And as we sit here today, I can't tell you what the

1 defendant's plan is to even start telling us how they are going  
2 to review or what they are going to review.

3 I understand, and I am sympathetic to the defendant's  
4 counsel, that there is a great deal of uncertainty and flux. I  
5 won't characterize it any more than that, let him do it, but  
6 there is a great deal of uncertainty. And so at this point, I  
7 wouldn't even know what we would be agreeing to with respect to  
8 additional time.

9 MR. BARDO: Your Honor, this case is complicated by  
10 the fact that there is an ongoing criminal investigation, which  
11 makes -- which a lot of these documents are relevant to. But  
12 we have -- there is a small subset of documents that the  
13 Foundation has determined that it can release. And I just  
14 spoke with them earlier this morning, and they do plan to make  
15 a partial release later today with redactions for personally  
16 identifiable information.

17 But the fact that there is an ongoing criminal  
18 investigation, and a lot of these requests are pretty broad,  
19 made it difficult. But what I would propose, Your Honor, is  
20 we'll send that production today and we'll work with plaintiff  
21 from there to put together a production schedule.

22 And if we need to withhold some of the records under  
23 Exemption 7(a), then we'll do that.

24 THE COURT: Any response from plaintiff's counsel?

25 MR. O'DONNELL: Thank you, Your Honor. I'm very

1 excited to hear that documents will be produced today. I guess  
2 good news. Whatever comes is good news.

3 So as far as my client is concerned, I think that the  
4 defendants and I can work out a schedule for release short of,  
5 at this point, maybe a joint proposed briefing schedule, if  
6 that's agreeable to the United States.

7 THE COURT: How far out should we set the next hearing  
8 when hopefully something productive would have occurred?

9 MR. BARDO: We would ask for 60 days, Your Honor, to  
10 ensure that the hearing is as productive as possible.

11 THE COURT: Very well. Hopefully during that period  
12 an assessment can be made as to which documents would be  
13 subject to the criminal prosecution, and, therefore, there  
14 might be a problem releasing those documents at that time.

15 And also, again, I don't know how many documents we're  
16 talking about, but if you could assess or get an assessment as  
17 to approximately how many documents we're talking about and  
18 conceivably how long it's going to take to do the processing.

19 Obviously, as far as those records that may be subject  
20 to the criminal prosecution, it may be difficult to predict how  
21 long it would take for conceivably those documents to be  
22 available for production if production is appropriate.

23 Otherwise, in reference to those documents that are  
24 not subject to the criminal prosecution, I think it would be  
25 helpful to find out how many documents we're talking about and

1 conceivably how long it would take to assess those documents  
2 and see whether production would be appropriate.

3 MR. BARDO: That makes sense.

4 THE COURT: I think a 60-day continuance is  
5 reasonable, so that would take us to March.

6 What about March 26th at 10 o'clock?

7 MR. BARDO: That works for the government, Your Honor.

8 MR. O'DONNELL: That works for the plaintiffs, Your  
9 Honor. Thank you.

10 DEPUTY CLERK: Your Honor, we already have a hearing  
11 set for March 26th at 10 o'clock. We put it in the last  
12 hearing that we had.

13 THE COURT: We could set this one for 11:00?

14 DEPUTY CLERK: Yes, that's fine.

15 THE COURT: Is that good for both counsel?

16 MR. BARDO: Works for the government, Your Honor.

17 MR. O'DONNELL: Works for Judicial Watch, Your Honor.

18 THE COURT: We'll talk to you at that time. We'll do  
19 it again by phone. Thank you.
