



## A Snapshot of the 2020 General Election in Fulton County

### On Nov 4: GA Secretary of State Brad Raffensperger said on the Today show:

- A record 4.7M Georgia ballots had been cast in GA
- President Trump was in the lead by 103,705 votes
- 94,000 ballots left to count (.02 of 4.7M)

- **Fast forward: On November 20, official results included *four (4) times* the number of ballots that were outstanding as of Nov 4**
  - 5,023,159 total ballots cast
  - Another ~300,000 ballots counted instead of the 94,000 ballots Raffensperger stated on Nov. 4 were left to be counted
- **Fulton County Absentee Ballots:**
  - o 74,000 absentee ballots were reported as cast when the polls closed on Election Day, Nov. 3
  - o But four days later, ~148,000 absentee ballots were counted
    - With no signature verification: only SIX rejections
  - o Over one million 'extra' absentee ballots were ordered by Fulton County on Oct 16, 2020 - after the deadline for mailing to voters
    - without envelopes: law requires absentee ballots to be mailed
    - without stubs: required by law for emergency or provisional ballots
  - o Tens of thousands of ballots arrived at the State Farm Arena on and after Election Day in **unsecured mail carts with no chain of custody**
  - o For the **~148,000 absentee ballots** in Fulton County:
    - 132,284 absentee ballot images have no .SHA file, created automatically when a ballot is scanned and is like a fingerprint used to authenticate the digital image of the ballot.
      - **Only 16,032** ballot images have their corresponding unique "fingerprint" authentication file
      - **132,286** ballot image SHA files deleted
      - Of those deletions, **104,994 ballot image files** contained modified time stamps, and other metadata anomalies
        - o Those electronic file anomalies and deleted authentication files strongly suggest deliberate ballot image file manipulation, *not* 'clerical error'
    - o According to Fulton County and the Secretary of State's records:
      - 148,319 absentee ballots were counted for the 2020 General Election from Fulton County...
      - but **only 125,784 voters** were recorded as casting an absentee ballot.

**Therefore, 25,534 more ballots were counted than voters recorded as having voted by absentee ballot in Fulton County**

- For all **IN PERSON VOTING** in Fulton County, both early and election day:
  - No digital record exists for **any** votes cast in person.
  - Every one of the **376,863** corresponding ballot images were destroyed, in violation of both federal and state law
- **Early (advance) voting** – 315,000 votes have NO backup records as required by GA law:
  - No daily recap sheets, no numbered lists of voters, and no poll pad check-in lists, all required by Georgia law: *No records exist for any early voting*
- **Tabulator Issues: No credible records for ANY in-person early voting.**
  - There is not one tabulator bearing the same serial number with an open AND close tape.
  - Of the tabulator closing tapes, which are the official returns, for **all** tabulators used for early voting's approximate 315,000 ballots, there are NO statutorily required accounting and chain of custody records
  - Of the 148 tabulators used in early voting, only nine (9) have the mandatory open / zero tapes
  - Ten of the 148 tabulators have NO closing tapes
  - Of the 138 closing tapes that do exist, none bear the serial number or identity of the machines used to actually scan the ballots
  - 20,713 ballots have no provenance as they were attributed to ten (10) early voting tabulators for which there are no records, and Fulton County claims the tabulators do not exist
- **A verifiable total of 19,691 votes in the hand recount, nearly twice the margin of victory between President Trump and Joe Biden, conflict with the November 3rd results.**
  - The post-election hand count **added 6,691** fictitious votes that became part of the certified total
    - Despite confirmation of the votes were fictitious, the totals have NEVER been corrected
    - NO investigation of the fictitious votes was ever conducted by Fulton County, the Secretary of State, or the Attorney General.
  - Another 13,000-vote discrepancy was found in the hand count/audit results as compared to the official returns for early voting
    - No investigation was conducted nor has an explanation ever been forthcoming
  - 3,930 ballots were scanned and counted twice. Hundreds of test ballots were also included and counted in the recount, not in the original count.
  - Thousands of ballots appear in the original November 3rd count that were not included in the recount, and vice versa.

**This does not include the significant factual evidence of:**

- o Removal of memory cards from tabulators *during* early voting, breaking tabulator seals prior to end of voting, using memory cards in multiple tabulators, falsification of tabulator records, destruction of the chain of custody of official results and tabulation records
- o Failure to test all machines *and software* prior to election
- o Installation of new 'emergency' software 'fix' and reprogramming of voting machines following logic & accuracy testing, with no subsequent re-testing – as required by law
- o Failure to reconcile results prior to certification
- o Disabling ballot paper authentication statewide
- o 773,309 absentee ballots ordered by Fulton County on Oct 16, 2020 never unaccounted for
- o None of the Raffensperger promised 'audits' were conducted: no statewide signature audit, no 'forensic audit of voting machines', and certainly no investigations of any of the issues raised in more than a dozen complaints about the 2020 general election over the past five years.
- o Voting system encryption keys provided in insecure, unprotected manner

The testimony in *Curling v Raffensperger* by Dr. Philip Stark summed up the issues of Fulton County's 2020 general election when he said that Fulton County does not know "how many voters cast votes" and its "lack of basic accounting controls make it impossible to determine who really won" in 2020, according to Philip Stark, a University of California, Berkeley professor who invented risk-limiting audits. Stark noted, "The electronic records of the election are not intact".
