Please see the below (and attached) talking points for your review. I am shooting these over to (b)(3),(b)(6) as well to ensure nothing on here is classified. I can tea up Hannity's team to touch on any of the topics she is most interested in covering. We can also work on fleshing out some of these thoughts with her, I just want her to have the facts on hand before she decides how to proceed.

Talking Points for Hannity 4.9.2025

DIG Stats and Functions:

- **The DIG is the A team of the intelligence community.**
- **We have brought on the best and the brightest from across 8+ intelligence elements, with a combined 275+ years of experience.**
- These detailees are already hard at work restoring transparency and accountability

across the IC by carrying out the tasks required by President Trump's intelligence-related Executive Orders.

- The DIG began its work by reviewing documents for potential declassification – including files related to COVID-19 origins, Crossfire Hurricane, MLK, RFK, JFK, and more – and identifying wasteful spending throughout the IC.

- President Trump promised the American people maximum transparency, and we are committed to executing the President's vision.

RFK Document Release

- **Per President Trump's directive, it is our intention to release the first 10,000 pages of declassified records related to the assassination of RFK this week.**
- A team of well over 100 staff, including approximately 20 individuals from ODNI, are digitizing and uploading the documents. This includes taking staples out of pages and uploading them by hand to the National Archives system.
- Unlike the JFK declassification, where a majority of the files were already digitized, the RFK files were packed away in boxes in warehouses and were mostly in a physical form.
- This week's release will be the first tranche of documents made digitally available to the American people. As more files are uncovered, we will digitize and upload them for review.

Biden Administration's Surveillance and Censorship Actions Against Americans:

- **As I promised and was requested by America First Legal, the DIG will declassify and release the **Strategic Implementation Plan for Biden Administration's Domestic Counterterrorism Strategy**, which could be made public as early as tomorrow.**
- This will be the first of many declassifications on the subject.
- The DIG is aggressively investigating how the government's counterterrorism apparatus was weaponized by the Biden Administration to silence and intimidate Americans.

Origins of COVID-19 Reevaluation:

- **The DIG is taking an unbiased, second look at the IC's assessment of the origins of COVID-19.**

- **The DIG has uncovered indications of bias and politicization within the intelligence community's election security assessments.**
 - Specifically, the DIG has uncovered indications that intelligence community (b)(5) had identified election system vulnerabilities that could be exploited by our adversaries and proceeded to withhold or (b)(5) this information from the American people.
 - (The Director in the meeting yesterday asked for the ugly truth hard-hitting information)
- The DIG is working overtime interviewing whistleblowers and reviewing documents necessary to declassify election related IC products.
